TITLE: Official Description Change: Unsigned Iowa 930, Marshall County

DISCUSSION/BACKGROUND:

Transfer of jurisdiction agreement number 89-TJ-007-64 between the Iowa Department of Transportation and Marshall County transferred unsigned Iowa 930 to county jurisdiction on December 26, 1989.

Unsigned Iowa 930 begins at the Marshall-Story County line and travels east to the west corporate limits of State Center. Beginning again at the east corporate limits of State Center, Iowa 930 travels easterly to junction with Iowa 330.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the description of unsigned Iowa 930 in Marshall County from the Primary Road System.

Old Description – Unsigned Iowa 930 in Marshall County described as follows:

Beginning on the Marshall-Story County line at a point near the NW Corner of Section 7-T83N-R20W, Marshall County (NE Corner of Section 12-T83N-R21W, Story County); thence easterly following substantially the section line of Sections 7, 8, and 9-T83N-R20W to a point approximately 250 feet west of the NE Corner of Section 9-T83N-R20W; thence curving in a southeasterly direction to a point approximately 250 feet south of the NE Corner of Section 9-T83N-R20W; thence southerly following substantially the section line of Section 10-T83N-R20W to the west corporation line of the City of State Center connecting with an unnamed street.

Beginning on the east corporation line of the City of State Center; thence easterly following substantially the center section line of Sections 11 and 12-T83N-R20W and Sections 7, 8, 9, 10, and 11-T83N-R19W to a point approximately 200 feet west of the center of Section 11-T83-R19W; thence southeasterly through Sections 11 and 12-T83N-R19W to a point approximately 650 feet east and 300 feet north of the SW Corner of Section 12-T83N-R19W (junction Iowa 330).

TITLE: Official Description Change: Unsigned Iowa 930, Marshall County

DISCUSSION/BACKGROUND:

Unsigned Iowa 930 begins at the Marshall-Story County line approximately three miles west of the City of State Center, and travels easterly via the City of State Center to US 330 approximately five miles west of the City of Marshalltown.

Transfer of jurisdiction agreement number TJ-930-0(4), between the City of State Center and the Iowa Department of Transportation, transferred unsigned Iowa 930 from the west corporation line easterly to the east corporation line to city jurisdiction on August 7, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the present description of unsigned Iowa 930 in Marshall County from the primary road system and

approve including the attached new description of unsigned Iowa 930 in the primary road system.

Locate unsigned Iowa 930 in Marshall County as follows:

Beginning on the Marshall–Story county line at a point near the NW Corner of Section 7–T83N–R20W, Marshall County (NE Corner of Section 12–T83N–R21W, Story County); thence easterly following substantially the section line of Sections 7, 8, and 9–T83N–R20W to a point approximately 250 feet west of the NE Corner of Section 9–T83N–R20W; thence curving in a southeasterly direction to a point approximately 250 feet south of the NE Corner of Section 9–T83N–R20W; thence southerly following substantially the section line of Section 10–T83N–R20W to the west corporation line of the City of State Center connecting with an unnamed street.

Beginning on the east corporation line of the City of State Center; thence easterly following substantially the center section line of Sections 11 and 12–T83N–R20W and Sections 7, 8, 9, 10, and 11–T83N–R19W to a point approximately 200 feet west of the center of Section 11–T83N–R19W; thence southeasterly through Sections 11 and 12–T83N–R19W to a point approximately 650 feet east and 300 feet north of the SW Corner of Section 12–T83N–R19W (junction Iowa 330).

TITLE: Unsigned Iowa 930, Marshall County, Iowa

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, Unsigned Iowa 930, in Marshall County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

Unsigned Iowa 930 begins on the Marshall–Story County line approximately 3 miles west of State Center, Iowa and travels in an easterly direction via State Center, Iowa terminating at the junction of Iowa 330 approximately 7 miles east of State Center, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate Unsigned Iowa 930 and its extension in Marshall County as follows:

Beginning on the Marshall–Story County line at a point near the NW Corner of Section 7–T83N–R20W, Marshall County (NE Corner of Section 12–T83N–R21W, Story County); thence easterly following substantially the section line of Sections 7, 8, and 9–T83N–R20W to a point approximately 250 feet west of the NE Corner of Section 9–T83N–R20W; thence curving in a southeasterly direction to a point approximately 250 feet south of the NE Corner of Section 9–T83N–R20W; thence southerly following substantially the section line of Section 13–T33N–R20W to the west corporation line of the city of State Center connecting with an unnamed street.

State Center:

Beginning on the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the city of State Center, connecting with an unnamed street; thence easterly following substantially the center section line of Sections 11 and 12–T83N–R20W and Sections 7, 8, 9, 10, and 11–T83N–R19W to a point approximately 200 feet west of the center of

Section 11-T83N-R19W; thence southeasterly through Sections 11 and 12-T83N-R19W (junction of Iowa 330) at a point approximately 650 feet east and 300 feet north of the SW Corner of Section 12-T83N-R19W.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Unsigned Iowa 930 in Marshall County, Iowa.

DISCUSSION/BACKGROUND:

US Alternate 30 should be updated to Unsigned Iowa 930 in Marshall County, Iowa and be officially included in the State Primary System.

PROPOSAL/ACTION RECOMMENDATION:

Locate Unsigned Iowa 930 as follows:

Beginning on the Marshall–Story County line at a point near the NW Corner Section 7–T83N–R20W, Marshall County (NE Corner of Section 12–T83N–R21W, Story County); thence east following substantially the section line to a point approximately 400 feet west of the NE Corner of Section 9–T83N–R20W; thence curving in a southeasterly direction to a point approximately 400 feet south of the NE Corner of Section 9–T83N–R20W; thence south to the west corporation line of the City of State Center, connecting with an unnamed street.

State Center:

Commencing on an unnamed street at the south corporation line of the City of State Center; thence easterly on said unnamed street to the east corporation line of the City of State Center.

Beginning at the east corporation line of the City of State Center connecting with an unnamed street; thence east following substantially the $\frac{1}{4}$ section line through Sections 11 and 12-T83N-R20W, Sections 7, 8, 9, 10 and 11-T83N-R19W to a point approximately 800 feet west of center of said Section 11; thence southeasterly to a point near the SE Corner of said Section 11 connecting with Iowa 330.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location on Unsigned Iowa 930 in Marshall County, Iowa.
