

DISCUSSION/BACKGROUND:

Senate File 451 transferred Unsigned Iowa 939 in its entirety, in Buchanan County, to county jurisdiction on July 1, 2003.

DISCUSSION/BACKGROUND:

US 20 was relocated from the Buchanan-Black Hawk County line approximately 1 ½ miles south of Jesup easterly to a junction with Iowa 150 at Independence. It was opened to traffic on August 26, 1983. The Buchanan County Functional Classification Board classified it as Freeway-Expressway and the old alignment of US 20 was classified as Trunk under the State Functional Classification System on October 13, 1985.

Transfer of jurisdiction agreement number TJ-939-0 (2) --2M-10 between the Iowa Department of Transportation and the City of Independence transferred that portion of old US 20 from the west corporation line easterly to the west junction of Iowa 150 and Unsigned

Iowa 939 from the east junction of Iowa 150 easterly to the east corporation line to city jurisdiction on April 15, 1985.

The old alignment of US 20 from the Buchanan–Black Hawk County Line at Jesup easterly to the west corporation line of Independence should be re-designated as a portion of Unsigned Iowa 939. The official description of Unsigned Iowa 939 should be revised to reflect these changes. The geographic location of the remainder of Unsigned Iowa 939 in Buchanan County remains unchanged.

Unsigned Iowa 939 begins at the Buchanan–Black Hawk County Line at Jesup and travels easterly to the west corporation line of Independence and from the east corporation line of Independence easterly to a junction with Iowa 187 approximately four miles east of Winthrop.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve revising the description of Unsigned Iowa 939 in Buchanan County and including the new description in the Primary Road System.

New Description – Unsigned Iowa 939 in Buchanan County described as follows:

Beginning on the Buchanan–Black Hawk County Line at a point near the SW Corner of Section 31–T89N–R10W, Buchanan County (SE Corner of Section 36–T89N–R11W, Black Hawk County); thence east along the Buchanan–Black Hawk County Line and the south corporation line of the City of Jesup to the NW Corner Section 6–T88N–R10W; thence easterly following substantially the section line of Sections 6, 5, 4, 3, 2 and 1–T88N–R10W and Sections 6 and 5–T88N–R9W to the west corporation line of the City of Independence connecting with 1st Street West.

Beginning again on the east corporation line of the City of Independence connecting with 1st Street West; thence easterly following substantially

the section line of Sections 3, 2 and 1–T88N–R9W and Sections 6, 5 and 4–T88N–R8W to a point approximately 700 feet east of the N ¼ Corner Section 4–T88N–R8W; thence in a southeasterly direction through Section 4–T88N–R8W and in an easterly and northeasterly direction through Section 3–T88N–R8W to a point approximately 600 feet west of the NE Corner of Section 3–T88N–R8W; thence east following substantially the section line Sections 3, 2 and 1–T88N–R8W and Sections 6, 5, 4 and 3–T88N–R7W to a point approximately 2300 feet east of the NW Corner Section 3–T88N–R7W (junction Iowa 187).

DISCUSSION/BACKGROUND:

Due to the relocation of US 20 in Buchanan County Unsigned Iowa 939 has been created and its description should be officially included in the primary road system.

Unsigned Iowa 939 begins at a junction with Iowa 150 in the City of Independence and proceeds easterly to a junction with Iowa 187 approximately four miles east of the City of Winthrop.

PROPOSAL/ ACTION RECOMMENDATION:

It is recommended the commission approve including the attached description of Unsigned Iowa 939 in Buchanan County in the primary road system.

Locate Unsigned Iowa 939 and its extension in Buchanan County as follows:

Independence:

Beginning on an unnamed street at Fifth Avenue Northeast (junction Iowa 150); thence easterly to the east corporation line connecting with an unnamed street.

Beginning on the east corporation line of the City of Independence connecting with an unnamed street; thence easterly following substantially the section line of Sections 3, 2 and 1-T88N-R9W and Sections 6, 5 and 4-T88N-R8W to a point approximately 700 feet east of the N $\frac{1}{4}$ Corner Section 4-T88N-R8W; thence in a southeasterly direction through Section 4-T88N-R8W and in an easterly and northeasterly direction through Section 3-T88N-R8W to a point approximately 600 feet west of the NE Corner of Section 3-T88N-R8W; thence east following substantially the section line Sections 3, 2 and 1-T88N-R8W and Sections 6, 5, 4 and 3-T88N-R7W to a point approximately 2300 feet east of the NW Corner Section 3-T88N-R7W (junction Iowa 187).
