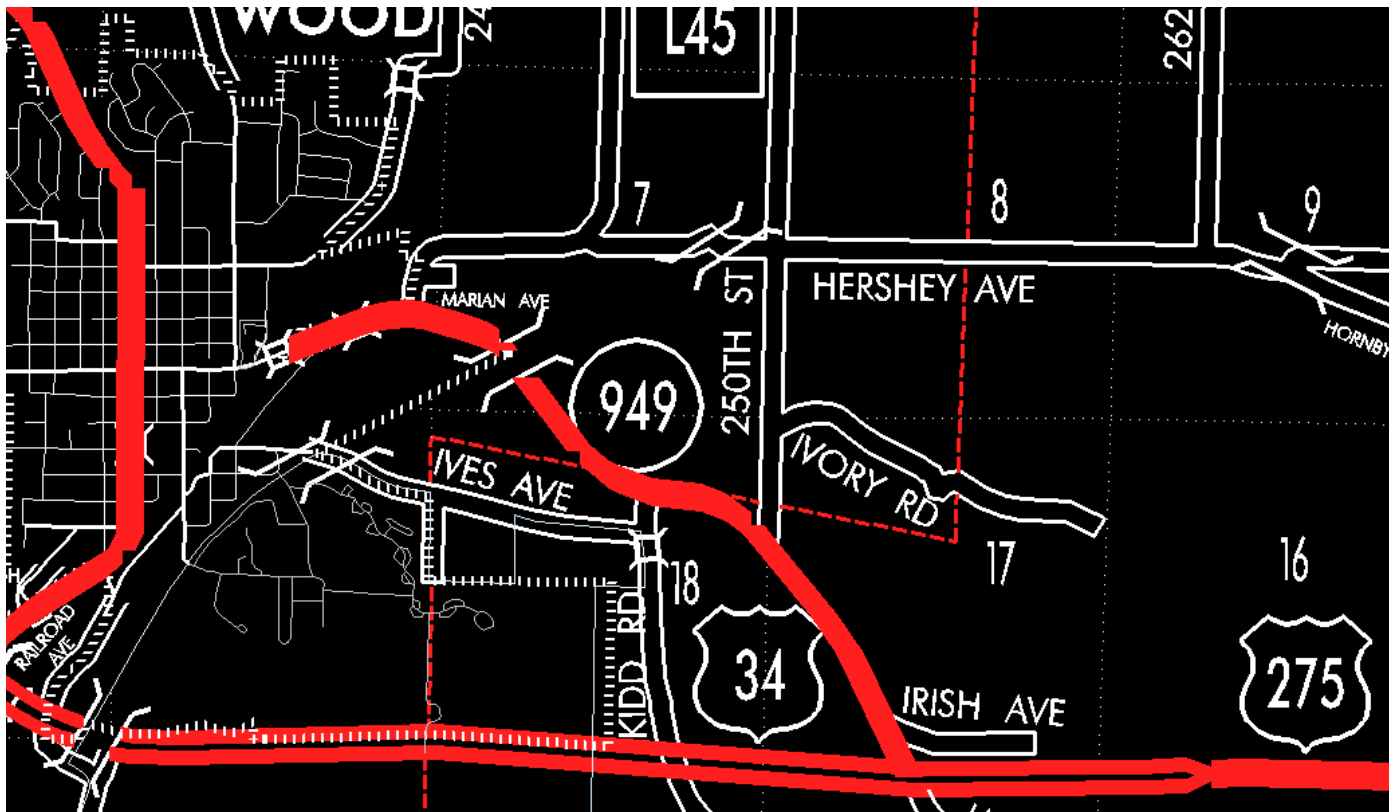

Transfer of jurisdiction agreement number TJ-949-0(5), between the Mills County and the Iowa Department of Transportation, transferred that portion of Unsigned Iowa 949 from east corporation line of the City of Glenwood connecting with Sharp Street; thence northeasterly and southeasterly through Section 12-T72N-R43W and southeasterly through Section 7-T72N-R43W and Sections 18 and 17-T72N-R42W to a point near the S $\frac{1}{4}$ Corner Section 17-T72N-R42W (junction US 34 and 275)

Due to a review of our Primary Road System records Unsigned Iowa 949 in Mills County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Unsigned Iowa 949 in Mills County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Unsigned Iowa 949 in Mills County as follows:

Beginning east corporation line of the City of Glenwood connecting with Sharp Street; thence northeasterly and southeasterly through Section 12-T72N-R43W and southeasterly through Section 7-T72N-R43W and Sections 18 and 17-T72N-R42W to a point near the S ¼ Corner Section 17-T72N-R42W (junction US 34 and 275).

Unsigned Iowa 949 in Mills County, Iowa, should be officially included in the State Primary System.

PROPOSAL/ACTION RECOMMENDATION:

Beginning at a point on new US 34 & US 275, 222 feet south of N $\frac{1}{4}$ Corner of Section 20; thence northwesterly through Section 20-T72N-R42W; thence northwesterly through Sections 17, 18, and 7-T72N-R42W; thence northwesterly, southwesterly through Section 12-T72N-R43W to a point on the east corporation line of the City of Glenwood connecting with unnamed street,

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Unsigned Iowa 949 in Mills County.
