Unsigned Iowa 951 begins in the SW ¼ Section 16-T72N-R26W approximately five miles west of the City of Osceola and proceeds southeasterly to a junction with US 34 approximately two miles west of the City of Osceola.

Transfer of jurisdiction agreement number TJ-951-0 (1)--2M-20, between Clarke County and the Iowa Department of Transportation, transferred Unsigned Iowa 951 from a point in the SW ¼ Section 16-T72N-R26W south-easterly, easterly and southeasterly to a junction with US 34 near the center of Section 23-T72N-R26W to county jurisdiction on September 2, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Unsigned Iowa 951 in Clarke County from the primary road system.

Remove Unsigned Iowa 951 in Clarke County as follows:

Beginning at a point in the SW ¼ Section 16-T72N-R26W; thence in a southeasterly direction through said Section 16 to a point approximately 800 feet east of the NW Corner Section 21-T72N-R26W; thence easterly following substantially the section line said Section 21 to a point near the NW Corner Section 22-T72N-R26W; thence southeasterly through Sections 22 and 23-T72N-R26W to a point near the center of Section 23-T72N-R26W (junction US 34).

Unsigned Iowa 951 begins at a county road approximately 4 ½ miles east and 1 mile south of Murray, and travels easterly and southeasterly to US 34 approximately 3 miles west and ½ mile south of Osceola, Iowa.

Due to a review of our Primary Road System Records Unsigned Iowa 951 in Clarke County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of Unsigned Iowa 951 in Clarke County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Unsigned Iowa 951 in Clarke County as follows:

Beginning at a point in the SW ¼ Section 16-T72N-R26W; thence in a southeasterly direction through said Section 16 to a point approximately 800 feet east of the NW Corner Section 21-T72N-R26W; thence easterly following substantially the section line said Section 21 to a point near the NW Corner Section 22-T72N-R26W; thence southeasterly through Sections 22 and 23-T72N-R26W to a point near the center of Section 23-T72N-R26W (junction US 34).

Unsigned Iowa 951 in Clarke County, Iowa should be officially included in the State Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

Beginning in the NW Corner of Section 21-T72N-R26W connecting with US 34 following northerly approximately 375 feet into Section 16-T72N-R26W; thence southeasterly; thence easterly along section line of Section 21-T72-R26W to a point in the NW Corner of Section 22-T72N-R26W; thence southeasterly through Sections 22 and 23-T72N-R26W to a point in approximately the center of Section 23-T72N-R26W connecting with US 34 in Clarke County.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of Unsigned Iowa 951 in Clarke County, Iowa.
