It is recommended that Unsigned Iowa 968, as described above, in Marion County be deleted from the Primary Road System

Transfer of jurisdiction agreement numbers 93-TJ-005 and 93-TJ-012 between the Iowa Department of Transportation, City of Pella, and Marion

County transferred Unsigned Iowa 968 to the City of Pella and Marion County on September 15, 1995.

Transfer beginning at relocated Iowa 163 through Pella and easterly to Iowa 102.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that Unsigned Iowa 968 in Pella and the rural section, as described above, be deleted from the Primary Road System.

TITLE: Unsigned Iowa 968 in Marion County

DISCUSSION/BACKGROUND:

Due to the relocation of Iowa 163 in 1994, the old section became Unsigned Iowa 968 and the Primary Road System should be revised to reflect this change.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that Unsigned Iowa 968, as described in the attachment, be added to the Primary Road System.

New description – Unsigned Iowa 968 and its extension in Marion County described as follows:

Pella:

Beginning on Washington Street at the west corporation line; thence southeast and east on Washington Street to Main Street; thence south on Main Street to Oskaloosa Street; thence east and southeast on Oskaloosa Street to the east corporation line.

Beginning again on the east corporation line of Pella connecting with Oskaloosa Street; thence southeasterly through Sections 11, 12, and 13-T76N-R18W to the Marion-Mahaska County line at a point approximately 650 feet south of the NE Corner of Section 13-T76N-R18W, Marion County (NW Corner Section 18-T76N-R17W, Mahaska County).
