TITLE: Unsigned Iowa 972, Madison County

DISCUSSION/BACKGROUND:

Unsigned Iowa 972 begins at a junction with US 169 approximately nine miles south of Winterset and travels in a northerly direction to a junction with US 169 and Iowa 92 in Winterset.

Due to an agreement between Madison County and the Iowa State Highway Commission approved May 2, 1974, that portion of Unsigned Iowa 972 from Section 14-T74N-R28W northerly to the south corporation line of Winterset should be deleted from the primary road system and reverted to the Madison County secondary road system.

Due to agreement number 78-6-148 between Winterset and the Iowa Department of Transportation that portion of Unsigned Iowa 972 from the Winterset south corporation line north to a junction with relocated US 169 and Iowa 92 should be deleted from the primary road system and reverted to the City street system of Winterset.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the description of Unsigned Iowa 972 in Madison County, as referred to in the attached detailed description, be deleted from the primary road system.

Remove Unsigned Iowa 972 and its extension in Madison County as follows:

Beginning at a point approximately ¼ mile east of the SW Corner Section 14-T74N-R28W; thence in a northeasterly direction through Sections 14, 13, and 12-T74N-R28W to a point near the NE Corner Section 12-T74N-R28W; thence northerly through Section 1-T74N-R28W, Section 6-T74N-R27W, and Section 1-T74N-R28W to a point near the NE Corner said Section 1; thence northerly following substantially the section line of Sections 31 and 30-T75N-R27W to a point approximately ½ mile south of the NW Corner Section 30-T75N-R27W; thence in a northeasterly, northerly, and northwesterly direction through Sections 30, 19, 18, 7, and 6-T75N-R27W to the south corporation line of the City of Winterset connecting with an unnamed street.

Winterset:

Commencing on unnamed street at the south corporation line; thence northwesterly and northerly to a junction with US 169 and Iowa 92.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System Records, unsigned Iowa 972 in Madison County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of unsigned Iowa 972 in Madison County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate Unsigned Iowa 972 and its extension in Madison County as follows:

Beginning at a point approximately $\frac{1}{4}$ mile east of the SW Corner Section 14-T74N-R28W; thence in a northeasterly direction through Sections 14, 13, and 12-T74N-R28W to a point near the NE Corner Section 12-T74N-R28W; thence northerly through Section 1-T74N-R28W, Section 6-T74N-R27W, and Section 1-T74N-R28W to a point near the NE Corner said Section 1; thence northerly following substantially the section line of Sections 31 & 30-T75N-R27W to a point approximately $\frac{1}{4}$ mile south of the NW Corner Section 30-T75N-R27W; thence in a northeasterly, northerly, and northwesterly direction through Sections 30, 19, 18, 7, and 6-T75N-R27W to the south corporation line of the City of Winterset connecting with an unnamed street.

Winterset

Commencing on unnamed street at the south corporation line; thence northwesterly and northerly to a junction with US 169 and Iowa 92.

TITLE: Unsigned Iowa 972 and its extension in Madison County

Locate Unsigned Iowa 972 and its extension in Madison County, Iowa, as follows:

Beginning at a point approximately $\frac{1}{4}$ mile east of the SW Corner Section 14-T74N-R28W; thence in a northeasterly direction through Sections 14, 13 and 12-T74N-R28W to a point near the NE Corner Section 12-T74N-R28W; thence north following substantially the section line to a point approximately $\frac{1}{4}$ mile south of the NW Corner Section 30-T75N-R27W; thence in a northeasterly, northerly, and northwesterly direction through Sections 30, 19, 18, 7 and 6-T75N-R27W to the south corporation line of the City of Winterset connecting with an unnamed street.

Winterset

Commencing on unnamed street at the south corporation line; thence northeasterly to the intersection of Summit Street and First Street; thence northerly on First Street to the north corporation line.

NOW, THEREFORE: Be it resolved that the Iowa State Highway Commission approve the location of Unsigned Iowa 972 and its extension in Madison County, Iowa.
