DISCUSSION/BACKGROUND:

Unsigned Iowa 973 begins at a junction with US 169 and Iowa 92 approximately one mile west of the City of Winterset and proceeds east to the west corporation line of the City of Winterset.

Transfer of jurisdiction agreement number TJ-973-0 (1)--2M-61, between Madison County and the Iowa Department of Transportation, transferred Unsigned Iowa 973 from US 169 and Iowa 92 near the N ¼ Corner Section 2-T75N-R28W east to the west corporation line of the City of Winterset to county jurisdiction on August 27, 1980.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended the commission approve deleting the attached description of Unsigned Iowa 973 in Madison County from the primary road system.

Remove Unsigned Iowa 973 in Madison County as follows:

Beginning at a point near the N ¼ Corner Section 2-T75N-R28W (junction Iowa 92); thence easterly following substantially the section line of Sections 2 and 1-T75N-R28W to the west corporation line of the City of Winterset.

TITLE: Unsigned Iowa 973. Madison County

DISCUSSION/BACKGROUND:

Unsigned Iowa 973 begins at a junction with US 169 and Iowa 92 approximately $\frac{3}{4}$ mile west of Winterset and travels easterly to Winterset.

Due to agreement number 78-6-148 between the City of Winterset and the Iowa Department of Transportation approved September 21, 1978, that portion of Unsigned Iowa 973 from the west corporation line of Winterset east to First Street should be deleted from the primary road system and reverted to the city street system of Winterset.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of Unsigned Iowa 973 in Madison County be deleted and the new description, as referred to in the attached detailed description, be included in the primary road system.

Locate Unsigned Iowa 973 in Madison County as follows:

Beginning at a point near the N $\frac{1}{4}$ Corner Section 2-T75N-R28W (junction Iowa 92); thence easterly following substantially the section line of Sections 2 and 1-T75N-R28W to the west corporation line of the City of Winterset.
