Remove Unsigned Iowa 973 and Extensions in Cass County as follows:

Beginning at a point approximately 1,000 feet west of the SE Corner of Section 2-T76N-R36W; thence easterly following substantially the section line to the west corporation line of Wiota, connecting with an unnamed street.

Wiota:

Beginning on an unnamed street at the west corporation line; thence easterly on said unnamed street to the east corporation line.

Beginning again on the east corporation line of Wiota connecting with an unnamed street; thence in a northeasterly direction along the north side of the Chicago, Rock Island and Pacific Railroad and substantially parallel thereto, through Sections 4, 3 and 2-T76N-R35W; Sections 35 and 36-T77N-R35W, and Sections 31, 30 and 29-T77N-R34W to the west corporation line of Anita, connecting with an unnamed street.

Anita:

Beginning on an unnamed street at the west corporation line; thence northeasterly on said unnamed street to Main Street; thence northeasterly on Main Street to Chestnut Street (Iowa 148).

NOW, THEREFORE: Be it resolved that the Iowa State Highway Commission approve the removal of Unsigned Iowa 973 in Cass County, Iowa.

Locate Unsigned Iowa 973 in Cass County as follows:

Beginning at a point approximately 1,000 feet west of the SE Corner of Section 2-T76N-R36W; thence easterly following substantially the section line to the west corporation line of Wiota, connecting with an unnamed street.

Wiota:

Beginning on an unnamed street at the west corporation line; thence easterly on said unnamed street to the east corporation line.

Beginning again on the east corporation line of Wiota connecting with an unnamed street; thence in a northeasterly direction along the north side of the Chicago, Rock Island and Pacific Railroad and substantially parallel thereto, through Sections 4, 3 and 2-T76N-R35W, Sections 35 and 36-T77N-R35W, and Sections 31, 30 and 29-T77N-R34W to the west corporation line of Anita, connecting with an unnamed street.

Anita:

Beginning on an unnamed street at the west corporation line; thence northeasterly on said unnamed street to Main Street; thence northeasterly on Main Street to Chestnut Street (Iowa 148).

NOW THEREFORE: Be resolved that the Iowa State Highway Commission approve the location of Unsigned Iowa 973 in Cass County, Iowa.

NOTE: To become effective January 1, 1973.
