**DISCUSSION/BACKGROUND:**

Unsigned Iowa 974 begins in the City of Mount Vernon and proceeds northwesterly four and one-half miles northwest of the City of Mount Vernon.

Transfer of jurisdiction agreement number TJ-974-0 (5)--2M-57, between the City of Mount Vernon and the Iowa Department of Transportation, transferred that portion of Unsigned Iowa 974 from the north right-of-way line of the Chicago and Northwestern Railroad northwesterly to the north corporation line of Mount Vernon to city jurisdiction on August 4, 1980.

Transfer of jurisdiction agreement number TJ-974-0 (6)--2M-57, between Linn County and the Iowa Department of Transportation, transferred that portion of Unsigned Iowa 974 from the north corporation line of the City of Mount Vernon northwesterly to a point near the NW Corner Section 25-T83N-R6W to county jurisdiction on August 5, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Unsigned Iowa 974 in Linn County from the primary road system.

Remove Unsigned Iowa 974 in Linn County as follows:

Beginning on the north corporation line of the City of Mount Vernon connecting with an unnamed street; thence in a northwesterly direction through Sections 9,

4 and 5-T82N-R5W; Sections 32 and 31-T83N-R5W and Section 25-T83N-R6W to a point near the NW Corner Section 25-T83N-R6W.

Beginning on the north corporation line of the City of Mount Vernon connecting with an unnamed street; thence in a northwesterly direction through Sections 9, 4, and 5-T82N-R5W; Sections 32 and 31-T83N-R5W and Section 25-T83N-R6W to a point near the NW Corner Section 25-T83N-R6W.
