**DISCUSSION/BACKGROUND:**

Transfer of jurisdiction agreement number TJ-964-0 (2)--2M-63 between the Iowa Department of Transportation, the City of Knoxville and Marion County transferred that portion of Unsigned Iowa 964 from a junction with Unsigned Iowa 975 in Knoxville easterly and southeasterly to a point of intersection with Iowa 92 to city and county jurisdiction on November 24, 1986.

To maintain continuity in the Iowa Route Numbering System, Unsigned Iowa 975 should be re-designated as a portion of Unsigned Iowa 964 and the official description of Unsigned Iowa 975 should be deleted from the primary road system to reflect this re-designation.

Unsigned Iowa 975 begins at a junction with Iowa 5 and 92 approximately one mile southeast of Knoxville and travels northwesterly to a junction with Unsigned Iowa 964 in Knoxville.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended to approve deleting the description of Unsigned Iowa 975 in Marion County from the primary road system.

Old description – Unsigned Iowa 975 and its extension in Marion County described as follows:

Beginning at a point approximately 250 feet west and 450 feet north of the center Section 17-T75N-R19W (junction Iowa 92 and Iowa 5); thence in a

northwesterly direction through Sections 17, 8 and 7-T75N-R19W to the south corporation line of the City of Knoxville connecting with an unnamed street.

Knoxville:

Beginning on the south corporation line connecting with an unnamed street; thence northerly to Main Street.

**DISCUSSION/BACKGROUND:**

Due to the relocation of Iowa 5 in the Knoxville area, unsigned Iowa 975 in Marion County has been created and its description should be officially included in the primary road system.

Unsigned Iowa 975 begins at a junction with Iowa 5 and 92 approximately one mile southeast of the City of Knoxville and proceeds northwesterly into the City of Knoxville.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve including the attached description of unsigned Iowa 975 in Marion County in the primary road system.

Locate unsigned Iowa 975 and its extension in Marion County as follows:

Beginning at a point approximately 250 feet west and 450 feet north of the center Section 17-T75N-R19W (junction Iowa 92 and Iowa 5); thence in a northwesterly direction through Sections 17, 8 and 7-T75N-R19W to the south corporation line of the City of Knoxville connecting with an unnamed street.

Knoxville:

Beginning on the south corporation line connecting with an unnamed street;  
thence northerly to Main Street.
