Unsigned Iowa 976 begins on the north corporation line of the City of Mount Pleasant, and travels northerly approximately two miles to US 218.

A State Functional Classification Review Board hearing, between the Iowa Department of Transportation (transferring jurisdiction) and Henry County (receiving jurisdiction) transferred Unsigned Iowa 976 from the north corporation line of the City of Mount Pleasant northerly and northeasterly to US 218 approximately 1200 feet north of the S  $\frac{1}{4}$  Corner NE  $\frac{1}{4}$  Section 28-T72N-R6W to county jurisdiction on April 6, 1981.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the present description of Unsigned Iowa 976 in Henry County from the primary road system.

Remove Unsigned Iowa 976 in Henry County as follows:

Beginning on the north corporation line of the City of Mount Pleasant connecting with an unnamed street; thence north following substantially the center section line of Section 4-T71N-R6W and Section 33-T72N-R6W to a point near the N  $\frac{1}{4}$  Corner of Section 33-T72N-R6W; thence in a northeasterly direction through Section 28-T72N-R6W to a point approximately 1200 feet north of the S  $\frac{1}{4}$  Corner NE  $\frac{1}{4}$  of Section 28-T72N-R6W (junction US 218).

Pleasant connecting with an unnamed street; thence north following substantially the center section line of Section 4-T71N-R6W and Section 33-T72N-R6W to a point near the N  $\frac{1}{4}$  Corner of Section 33-T72N-R6W; thence in a northeasterly direction through Section 28-T72N-R6W to a point approximately 1200 feet north of the S  $\frac{1}{4}$  Corner NE  $\frac{1}{4}$  of Section 28-T72N-R6W (junction US 218).
