**DISCUSSION/BACKGROUND:**

Unsigned Iowa 983 begins approximately one-quarter mile west of the City of Chariton and proceeds easterly to the west corporation line of the City of Chariton and begins again on the east corporation line of the City of Chariton and proceeds easterly to a junction with US 34 approximately one-half mile east of the City of Chariton.

Transfer of jurisdiction agreement number TJ-983-0 (2) --2M-59, between Lucas County and the Iowa Department of Transportation, transferred Unsigned Iowa 983 from a point approximately one-quarter mile west of the NE Corner Section 25-T72N-R22W east to the west corporation line of the City of Chariton and from the east corporation line of the City of Chariton easterly to a junction with US 34 near the center of the SE ¼ Section 28-T72N-R21W to county jurisdiction on July 1, 1980.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the commission approve deleting the attached description of Unsigned Iowa 983 in Lucas County from the primary road system.

Remove Unsigned Iowa 983 in Lucas County as follows:

Beginning at a point approximately one-quarter mile west of the NE Corner Section 25-T72N-R22W (junction US 34); thence east following

substantially the section line of said Section 25 to the west corporation line of the City of Chariton connecting with an unnamed street.

Beginning on the east corporation line of the City of Chariton, connecting with an unnamed street; thence easterly through Sections 29 and 28-T72N-R21W to a point near the center of the SE ¼ Section 28-T72N-R21W (junction US 34).

Beginning on the east corporation line of the City of Chariton, connecting with an unnamed street; thence easterly through Sections 29 and 28-T72N-R21W to a point near the center of the SE ¼ Section 28-T72N-R21W (junction US 34).

**PROPOASL/ACTION RECOMMENDATION:**

Locate Unsigned Iowa 983 in Lucas County, Iowa as follows:

Beginning at a point approximately ¼ mile west of the NE Corner Section 25-T72N-R22W; thence east following substantially the section line to the west corporation line of the city of Chariton and an unnamed street.

Beginning on the east corporation line of the City of Chariton, connecting with an unnamed street; thence easterly through Sections 29 and 28-T72N-R21W to a point near the center of the SE ¼ Section 28-T72N-R21W, connecting with present US 34.
