Beginning at the Cass-Pottawattamie County line at a point near the NW Corner Section 7-T75N-R37W, Cass County (NE Corner Section 12-T75N-R38W, Pottawattamie County); thence east following substantially the section line through Sections 7, 8, 9, 10 and 11-T75N-R37W; to a point 500 feet east of the NW Corner Section 11-T75N-R37W; thence in a northeasterly direction through Section 2-T75N-R37W and Sections 35, 26, 25, 24, and 13-T76N-R37W to the south corporation line of Atlantic connecting with an unnamed street.

Atlantic:

Beginning on an unnamed street at the south corporation line; thence northeast on unnamed street to 7th Street; thence east on 7th Street to the east corporation line.

Beginning again at the east corporation line of Atlantic (south junction US 71) connecting with 7th Street; thence east following substantially the section line through Sections 10 and 11-T76N-R36W to a point near the NE Corner Section 11-T76N-R36W (east junction Iowa 83); thence north following substantially the section line of Section 1-T76N-R36W and Sections 36, 25, 24, 13, 12 and 1-T77N-R36W (west junction Interstate 80 and north junction US 71); thence east following substantially the center section line (on Interstate 80) of Section 1-T77N-R36W and Sections 6, 5, 4, 3, 2, and 1-T77N-R35W and Sections 6, 5, 4, 3, 2, and 1-T77N-R34W to the Cass-Adair County line near the E ¼ Corner Section

1-T77N-R34W, Cass County (W ¼ Corner Section 6-T77N-R33W, Adair County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, US 6 in Cass County should be deleted, and the new description added should be officially included into the Primary Road System.

US 6 begins at the Cass-Pottawattamie County line, 4 ½ miles northwest of Lewis, travels in a northeasterly direction to Interstate 80 then is concurrent with Interstate 80 to the Cass-Adair County line via the City of Atlantic, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 6 and its extension in Cass County as follows:

Beginning at the Cass-Pottawattamie County line at a point near the NW Corner Section 7-T75N-R37W, Cass County (NE Corner Section 12-T75N-R38W, Pottawattamie County); thence east following substantially the section line through Sections 7, 8, 9, 10 and 11-T75N-R37W; to a point 500 feet east of the NW Corner Section 11-T75N-R37W; thence in a northeasterly direction through Section 2-T76N-R37W and Sections 35, 26, 25, 24, and 13-T76N-R37W to the

south corporation line of the City of Atlantic connecting with an unnamed street.

Atlantic:

Beginning at the south corporation line connecting with an unnamed street; thence northeasterly and easterly to the east corporation line connecting with an unnamed street.

Beginning again at the east corporation line of the City of Atlantic (west junction US 71) connecting with an unnamed street; thence easterly following substantially the line through Sections 10 and 11-T76N-R36W to a point near the NE Corner Section 11-T76N-R36W (east junction Iowa 83); thence north following substantially the section line of Section 1-T76N-R36W and Sections 36, 25, 24, 13, 12 and 1-T77N-R36W to a point on Interstate 80 (north junction US 71); thence east following substantially the center section line (on Interstate 80) of Section 1-T77N-R36W and Sections 6, 5, 4, 3, 2 and 1-T77N-R35W and Sections 6, 5, 4, 3, 2 and 1-T77N-R34W to the Cass-Adair County line near the E $\frac{1}{4}$ Corner Section 1-T77N-R34W, Cass County (W $\frac{1}{4}$ Corner Section 6-T77N-R33W, Adair County).

NOW, THEREFORE; be it resolved that the Iowa Department of Transportation approve the location of US 6 in Cass County, Iowa.

following substantially the section line through Sections 10 and 11-T76N-R36W (east junction US 71 and Iowa 83) to a point approximately 1,000 feet west of NE Corner Section 11-T76N-R36W; thence curving in a northeasterly direction to a point approximately 1,000 feet north of the SW Corner of Section 2-T76N-R36W; thence north following substantially the section line of Section 1-T76N-R36W and Sections 36, 25, 24, 13, 12 and 1-T77N-R36W to a point on Interstate 80; thence east following substantially the center section line (on Interstate 80) of Section 1-T77N-R36W and Sections 6, 5; 4, 3, 2 and 1-T77N-R35W and Sections 6, 5, 4, 3, 2 and 1-T77N-R34W to the Cass-Adair County line near the E $\frac{1}{4}$ Corner Section 1-T77N-R34W, Cass County (W $\frac{1}{4}$ Corner Section 6-T77N-R33W, Adair County).

NOW, THEREFORE: be it resolved that the Iowa Department of Transportation approve the location of US 6 in Cass County, Iowa.

Beginning on the east corporation line of Atlantic connecting with Seventh Street; thence easterly following substantially the section line to a point approximately 1,000 feet west of the SE Corner of Section 2-T76N-R36W; thence curving in a northeasterly direction to a point approximately 1,000 feet north of the SE Corner of Section 2-T76N-R36W; thence northerly following substantially the section line to a point near the E ¼ Corner of Section 2-T77N-R36W (junction Interstate 80); thence easterly following substantially the quarter section line (Interstate 80) to the Cass-Adair County line near the E ¼ Corner of Section 1-T77N-R34W, Cass County (W ¼ Corner of Section 6-T77N-R33W, Adair County).

NOW THEREFORE: Be it resolved that the Iowa State Highway Commission approve the revision of US 6 in Cass County, Iowa.

NOTE: To become effective January 1, 1973. The old location of US 6 from the east junction of US 71 easterly to Iowa 148 in Anita will become Unmarked Iowa 973. The old location of US 6 from Anita to the Cass-Adair County line will revert to the Cass County Secondary Road System as per agreement dated 19 July 1972.
