New Description – US 18 and its extensions in Fayette County described as follows:

Beginning at the Fayette–Chickasaw County line at a point near the NW Corner of Section 18–T94N–R10W, Fayette County (NE Corner Section 13–T94N–R11W, Chickasaw County); thence east following substantially the section line of Sections 18, 17 (junction Iowa 193), 16, 15, 14, and 13–T94N–R10W and Sections 18, 17, 16, 15, 14, 13–T94N–R9W and Section 18–T94N–R8W to the west corporation line of West Union, connecting with Bradford Street.

West Union:

Beginning at the west corporation line connecting with Bradford Street; thence east on Bradford Street to the east corporation line.

Beginning again at the east corporation line of West Union, connecting with Bradford Street; thence in an easterly and northeasterly direction through Sections 16, 9, 10, 3, 2, and 1–T94N–R8W and Sections 6, 5, and 4–T94N–R7W, and Section 33–T95N–R7W to the west corporation line of Clermont, connecting with Mill Street.

Clermont:

Beginning at the west corporation line connecting with Mill Street; thence east and northeast on Mill Street to the north corporation line.

Beginning again at the north corporation line of Clermont, connecting with Mill Street; thence in a northeasterly and northerly direction through Sections 27,

26, 23, 24, 13, and 12–T95N–R7W to a point on the Fayette–Clayton County line approximately ¼ mile south of the NE Corner of Section 12–T95N–R7W, Fayette County (NW Corner of Section 7–T95N–R6W, Clayton County); thence north along the Fayette–Clayton County line (see Clayton County) to a point approximately ¼ mile south of the NE Corner of Section 1 T95N–R7W, Fayette County (NW Corner of Section 6–T95N–R6W, Clayton County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, US 18 in Fayette County, Iowa should be deleted and the new description added should be officially included into the Primary System.

US 18 begins at the Fayette–Chickasaw County line approximately 8 miles northwest of Hawkeye and travels in an easterly and northeasterly direction via the Cities of West Union and Clermont to the Fayette–Clayton County line in the northeast corner of Fayette County.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 18 and its extensions in Fayette County as follows:

Beginning at the Fayette–Chickasaw County line at a point near the NW Corner of Section 18–T94N–R10W, Fayette County (NE Corner Section 13–T94N–R11W, Chickasaw County); thence east following substantially the section line of

Sections 18, 17 (junction Iowa 193), 16, 15, 14, and 13–T94N–R10W and Sections 18, 17, 16, 15, 14, 13–T94N–R9W and Section 18–T94N–R8W to the west corporation line of the City of West Union, connecting with an unnamed street.

West Union:

Beginning at the west corporation line connecting with an unnamed street; thence easterly to the east corporation line connecting with an unnamed street.

Beginning again at the east corporation line of the City of West Union, connecting with an unnamed street; thence in an easterly and northeasterly direction through Sections 16, 9, 10, 3, 2, and 1–T94N–R8W and Sections 6, 5, and 4–T94N–R7W, and Section 33–T95N–R7W to the west corporation line of the City of Clermont, connecting with an unnamed street.

Clermont:

Beginning at the west corporation line connecting with an unnamed street; thence easterly and northeasterly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of the City of Clermont, connecting with an unnamed street; thence in a northeasterly and northerly direction through Sections 27, 26, 23, 24, 13, and 12–T95N–R7W to a point on the Fayette–Clayton County line approximately $\frac{1}{4}$ mile south of the NE Corner of Section 12–T95N–R7W, Fayette County (NW Corner of Section 7–T95N–R6W, Clayton County); thence north along the Fayette–Clayton County line (see Clayton County) to a point approximately $\frac{1}{4}$ mile south of the NE Corner of Section 1–T95N–R7W, Fayette County (NW Corner of Section 6–T95N–R6W, Clayton County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 18 in Fayette County, Iowa.

NOTE: To become effective upon the adoption of this resolution.

Beginning on the Fayette-Chickasaw County line at a point near the SW Corner of Section 7-T94N-R10W, Fayette County (SE Corner of Section 12-T94N-R11W, Chickasaw County); thence east following substantially the section line to the west corporation line of the City of West Union connecting with Bradford Street.

Beginning again on the east corporation line of the City of West Union, connecting with Bradford Street; thence in a northeasterly and easterly direction through Section 9, 10, 3, 2 and 1-T94N-R8W, Section 6, 5 and 4-T94N-R7W, and Section 33-T95N-R7W to the west corporation line of the Town of Clermont, connecting with an unnamed street.

Beginning again on the north corporation line of the Town of Clermont, connecting with the extension of Mill Street; thence in a northeasterly and northerly direction through Section 27, 26, 23, 24, 13 and 12-T95N-R7W to a point on the Fayette-Clayton County line approximately $\frac{1}{4}$ mile south of the NE Corner of Section 12-T95N-R7W, Fayette County (NW Corner of Section 7-T95N-R6W, Clayton County); thence north along the Fayette-Clayton County line to a point near the E $\frac{1}{4}$ Corner of Section 1-T95N-R7W, Fayette County (W $\frac{1}{4}$ Corner of Section 6-T95N-R6W, Clayton County).
