New Description – US 30 and its extensions in Tama County described as follows:

Beginning on the Tama–Marshall County line (east corporation line of Le Grand connecting with Main Street) at a point near the NW Corner Section 18–T83N–R16W; thence east through said Section 18 and generally southeasterly through Sections 17, 16, 15, 14 and 13–T83N–R16W and Sections 18, 17 and 21–T83N–R15W to the west corporation line of Toledo.

Toledo:

Beginning on the west corporation line, thence southeast through section 22 and 23–T83N–R15W to the west corporation line of Toledo, then southeasterly through Sections 26, and 25–T83N–R15W then east following substantially the north section line of sections 31, 32, 33, 34, 35 and 36–T83N–R14W continuing east along the section lines of 31, 32, 33, 34, 35 and 36–T83N–R14W to the Tama–Benton County line at a point near the SE Corner Section 25–T83N–R13W Tama County (SW Corner Section 30–T83N–R13W Benton County) (junction Iowa 21).

New Description – US 30 and its extensions in Tama County described as follows:

Beginning on the Tama–Marshall County line (east corporation line of Le Grand connecting with Main Street) at a point near the NW Corner Section 18–T83N–R16W; thence east through said Section 18 and generally southeasterly through Sections 17, 16, 15, 14 and 13–T83N–R16W and Sections 18, 17 and 21–T83N–R15W to the west corporation line of Toledo, connecting with an unnamed street.

Toledo:

Beginning on the west corporation line connecting with an unnamed street; thence southeast to the south corporation line (north corporation line of Tama), connecting with an unnamed street.

Tama:

Beginning on the north corporation line (south corporation line of Toledo) connecting with an unnamed street; thence in a southeasterly direction to the east corporation line, connecting with an unnamed street.

Beginning again on the east corporation line of Tama connecting with an unnamed street; thence east following substantially the section line of Section 36–T83N–R15W; Sections 31, 32, 33, 34, 35 and 36–T83N–R14W and Sections 31, 32, 33, 34, 35 and 36–T83N–R13W to the Tama–Benton County line at a point near the SE Corner Section 25–T83N–R13W Tama County (SW Corner Section 30–T83N–R12W Benton County) (junction Iowa 21).

**DISCUSSION/BACKGROUND:**

US 30 begins on the Tama-Marshall County line at the east corporation line of Le Grand, and travels southeasterly and easterly via Toledo and Tama to the Tama-Benton County line approximately 1 mile east and 3 miles south of Elberon, Iowa.

Due to a review of our Primary Road System Records US 30 in Tama County should be deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of US 30 in Tama County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate US 30 and its extensions in Tama County as follows:

Beginning on the Tama–Marshall County line (east corporation line of the City of Le Grand) at a point near the NW Corner Section 18–T83N–R16W; thence easterly through said Section 18 and generally southeasterly through Sections 17, 16, 15, 14, and 13–T83N–R16W and Sections 18, 17, and 21–T83N–R15W to the west corporation line of the City of Toledo connecting with an unnamed street.

Toledo:

Beginning on the west corporation line connecting with an unnamed street; thence southeasterly to the south corporation line (north corporation line of the City of Tama) connecting with an unnamed street.

Tama:

Beginning on the north corporation line/south corporation line of the City of Toledo connecting with an unnamed street; thence in a southeasterly direction to the east corporation line connecting with an unnamed street.

Beginning again on the east corporation line of the City of Tama connecting with an unnamed street; thence easterly following substantially the section line of Section 36-T83N-R15W; Sections 31, 32, 33, 34, 35 and 36-T83N-R14W and Sections 31, 32, 33, 34, 35, and 36-T83N-R13W to the Tama-Benton County line at a point near the SE Corner Section 25-T83N-R13W Tama County (SW Corner Section 30-T83N-R12W Benton County) (junction Iowa 21).

thence southeasterly to a point 187.4 feet south of the E ¼ Corner Section 15-T83N-R16W; thence southeasterly to a point 163.5 feet south of the W ¼ Corner of Section 13-T83N-R16W; thence southeasterly to a point 539.9 feet south of the E ¼ Corner Section 13-T83N-R16W; thence southeasterly to a point 919.9 feet north of the SW Corner of Section 17-T83N-R15W; thence southeasterly to a point 29.9 feet south of the NW Corner Section 21-T83N-R15W; thence southeasterly to the west corporation line of the Town of Toledo.
