Beginning on Springfield Drive at the south corporation line (Allamakee-Clayton County line); thence northwesterly on Springfield Drive to Military Road; thence west on Military Road to Lawler Street; thence north on Lawler Street to Tilden Street; thence west on Tilden Street to the west corporation line.

Beginning on the west corporation line of Postville connecting with Tilden Street; thence in a generally northwesterly direction through Sections 32, 31 (junction US 18) and 30-T96N-R6W to the Allamakee-Winneshiek County line at a point approximately 800 feet north of the SW Corner of Section 30-T96N-R6W, Allamakee County (SE Corner of Section 25-T96N-R7W, Winneshiek County).

Beginning on the west corporation line of the City of Postville connecting with an unnamed street; thence in a generally northwesterly direction through Sections 32, 31 (junction US 18) and 30-T96N-R6W to the Allamakee, Winneshiek County line at a point approximately 800 feet north

of the SW Corner of Section 30–T96N–R6W, Allamakee County (SE Corner of Section 25–T96N–R7W, Winneshiek County).
