New Description – US 59 and its extension in Page County described as follows:

Beginning on the Page-Fremont County line at a point approximately 600 feet south of the W $\frac{1}{4}$ Corner Section 31-T69N-R39W, Page County (E $\frac{1}{4}$ Corner Section 36-T69N-R40W, Fremont County); thence northerly along the Page-Fremont County line following substantially the section line of Section 31-T69N-R39W to a point (south junction Iowa 2) near the SW Corner Section 30-T69N-R39W; thence northerly through Sections 30 and 19-T69N-R39W to the south corporation line of Shenandoah connecting with an unnamed street.

Shenandoah:

Beginning on the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of Shenandoah, connecting with an unnamed street; thence northerly along the Page-Fremont County line following substantially the section line of Sections 19, 18, 7, and 6-T69N-R39W and Sections 31, 30, 19, and 18-T70N-R39W to a point (junction Iowa 184) approximately 750 feet south of the NW Corner Section 18-T70N-R39W; thence northerly along the Page-Fremont County line following substantially the section line of Sections 18 and 7-T69N-R39W to a point approximately 1,000 feet south of the NW Corner Section 7-T70N-R39W, Page County (NE Corner Section 12-T70N-R40W, Fremont County).

Due to a review of our Primary Road System Records, US 59 in Page County should be deleted and the new description added should be officially included into the Primary System.

US 59 begins on the Page-Fremont County line approximately 2 ½ miles south of Shenandoah, and travels northerly along the Page-Fremont County line via the City of Shenandoah to a point on the Page-Fremont County line approximately 1 mile south of the NW Corner of Page County, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 59 and its extension in Page County as follows:

Beginning on the Page-Fremont County line at a point approximately 600 feet south of the W ¼ Corner Section 31-T69N-R39W, Page County (E ¼ Corner Section 36-T69N-R40W, Fremont County); thence northerly along the Page-Fremont County line following substantially the section line of Section 31-T69N-R39W to a point (south junction Iowa 2) near the SW Corner Section 30-T69N-R39W; thence northerly through Sections 30 and 19-T69N-R39W to the south corporation line of the City of Shenandoah connecting with an unnamed street.

Shenandoah:

Beginning on the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Shenandoah, connecting with an unnamed street; thence northerly along the Page-Fremont County line following substantially the section line of Sections 19, 18, 7, and 6-T69N-R39W and Sections 31, 30, 19, and 18-T70N-R39W to a point (junction Iowa 184) approximately 750 feet south of the NW Corner Section 18-T70N-R39W; thence northerly along the Page-Fremont County line following substantially the section line of Sections 18 and 7-T69N-R39W to a point approximately 1000 feet south of the NW Corner Section 7-T70N-R39W, Page County (NE Corner Section 12-T70N-R40W, Fremont County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 59 in Page County, Iowa.
