New Description – US 65 and its extension in Story County described as follows:

Beginning on the Story-Jasper County line at a point near the SW Corner Section 33-T82N-R21W, Story County (NW Corner Section 4-T81N-R21W, Jasper County); thence north following substantially the section line of Sections 33, 28 and 21-T82N-R21W to the south corporation line of Collins, connecting with 1st Avenue.

Collins:

Beginning on 1st Avenue at the south corporation line; thence north on 1st Avenue to the north corporation line.

Beginning again on the north corporation line of Collins connecting with 1st Avenue; thence north following substantially the section line of Sections 16, 9 and 4-T82N-R21W, Sections 33, 28, 21, 16 (junction US 30), 9 and 4-T83N-R21W; Sections 33, 28, 21, 16, 9 and 4-T84N-R21W; Sections 33, 28, 21, 16, 9 and 4-T85N-R21W to the Story-Hardin County line at a point near the NW Corner Section 4-T85N-R21W Story County (SW Corner Section 33-T86N-R21W Hardin County).

**DISCUSSION/BACKGROUND:**

US 65 begins on the Story–Jasper County line approximately 3 miles south of Collins, and travels northerly via Collins to the Story–Hardin County line approximately 3 miles north and 1 mile west of Zearing.

Due to a review of our Primary Road System Records US 65 in Story County should be officially deleted and the new description added should be officially included into the Primary System.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of US 65 in Story County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate US 65 and its extension in Story County as follows:

Beginning on the Story-Jasper County line at a point near the SW Corner Section 33-T82NR21W, Story County (NW Corner Section 4-T81N-R21W, Jasper County) thence northerly following substantially the section line of Sections 33, 28, and 21-T82N-R21W to the south corporation line of the City of Collins connecting with an unnamed street.

Collins:

Beginning on the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Collins connecting with an unnamed street; thence northerly following substantially the section line of Sections 16, 9, and 4-T82N-R21W, Sections 33, 28, 21, 16 (junction US 30), 9, and 4-T83N-R21W; Sections 33, 23, 21, 16, 9, and 4-T84N-R21W and Sections 33, 28, 21, 16, 9 and 4-T85N-R21W to the Story-Hardin County line at a point near the NW Corner Section 4-T85N-R21W Story County (SW Corner Section 33-T86N-R21W Hardin County).

Beginning at a point approximately 1000 feet west of the SE Corner Section 5-T83N-R21W; thence curving in a northeasterly direction to a point approximately 1000 feet north of the SE Corner Section 5-T83N-R21W.
