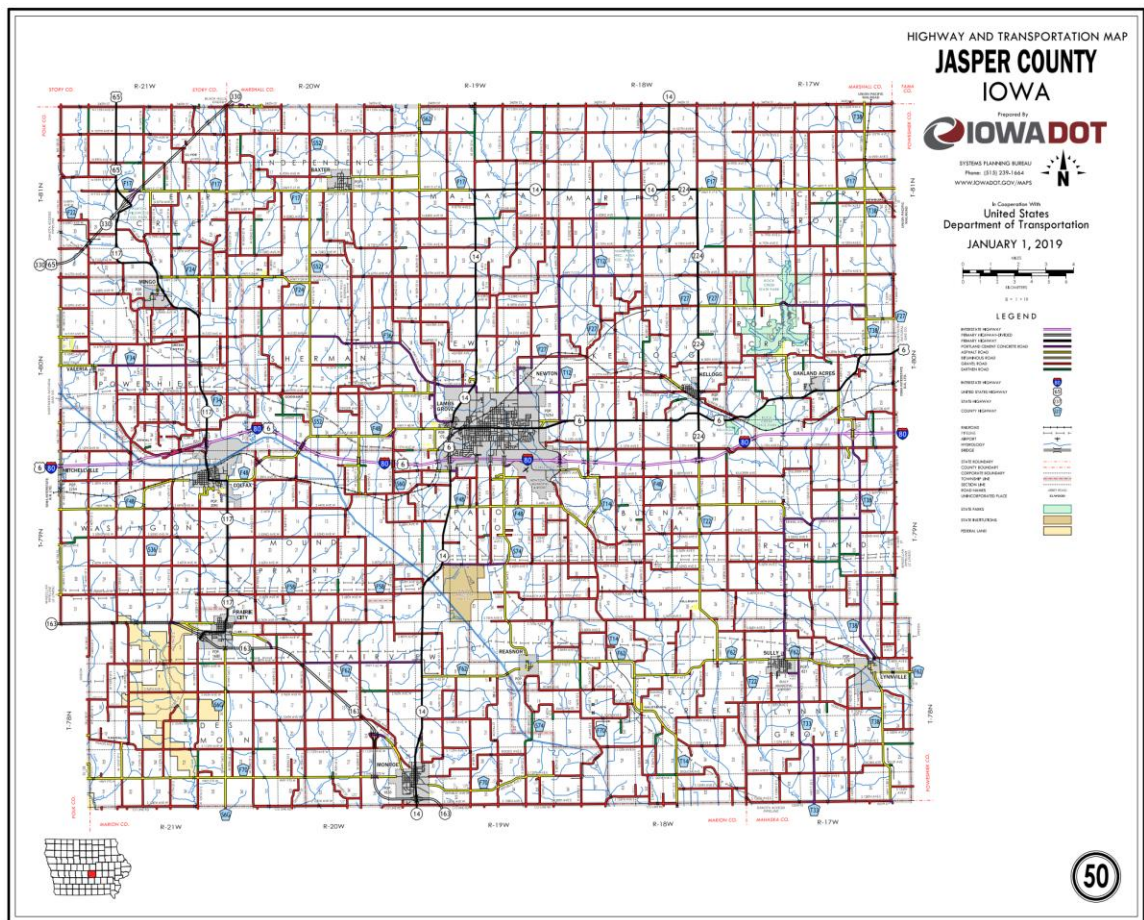

New Description – US 65 and its extensions in Jasper County described as follows:

Beginning on the Jasper–Polk County line at a point near the W $\frac{1}{4}$ Corner of Section 31–T81N–R21W, Jasper County (E $\frac{1}{4}$ Corner of Section 36–T81N–R22W, Polk County); thence in a northeasterly direction through

Sections 31, 30, 29, and 20-T81N-R21W to a point approximately 3300 feet north and 2100 feet east of the SE Corner of Section 20-T81N-R21W of the SE Corner of Section 20-T81N-R21W (junction of Iowa 117 and 330); thence northwesterly on Sections 21 and 16-T81N-R21W and northerly following substantially the section line of Sections 16, 9, and 4-T81N-R21W to the Jasper-Story County line to a point near the NW Corner of Section 4-T81N-R21W, Jasper County (SW Corner of Section 33-T82N-R21W, Story County).

DISCUSSION / BACKGROUND:

New Description – US 65 and its extensions in Jasper County described as follows:

Beginning on the Jasper-Polk County line at a point near the W $\frac{1}{4}$ Corner of Section 31-T81N-R21W, Jasper County (E $\frac{1}{4}$ Corner of Section 36-T81N-R22W, Polk County); thence in a northeasterly direction through Sections 31, 30, 29, and 20-T81N-R21W to a point approximately 1500 feet north and 240 feet east of the SE Corner of Section 20-T81N-R21W (junction of Iowa 117 and 330); then northwesterly and northerly following substantially the section line of Sections 21, 16, 9, and 4-T81N-R21W to the Jasper-Story County line to a point near the NW Corner of Section 4-T81N-R21W, Jasper County (SW Corner of Section 33-T82N-R21W, Story County).

PROPOSAL /ACTION RECOMMENDATION:

It is recommended that the old description of US 65 and its extensions in Jasper County be deleted and the new description be included in the Primary Road System.

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records US 65 in Jasper County should be deleted from the Primary Road System and the new description added should be officially included into the Primary Road System.

US 65 begins at the Jasper-Polk County line approximately 3 ½ miles northwest of Mingo and travels in a northeasterly and northerly direction to the Jasper-Story county line approximately 3 ½ miles north of the junction of US 65, Iowa 330 and Iowa 117.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 65 in Jasper County, Iowa as follows:

Beginning on the Jasper-Polk County line at a point approximately 600 feet north of the SW Corner Section 31-T81N-R21W, Jasper County (SE Corner Section 36-T81N-R22W, Polk County); thence in a northeasterly direction thru Section 31, 30, 29 and 20-T81N-R21W to a point

approximately 1200 feet north of the SE Corner Section 20–T81N–R21W (junction Iowa 117 and 330); thence north following substantially the section line of Sections 21, 16, 9 and 4–T81N–R21W to the Jasper–Story County line to a point near the NW Corner Section 4–T81N–R21W, Jasper County (SW Corner Section 33–T82N–R21W, Story County.)

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 65, Jasper County, Iowa.
