DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records US 67 in Jackson County should be deleted and the new description added should be officially included into the Primary System.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of US 67 in Jackson County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate US 67 in Jackson County as follows:

Beginning on the Jackson-Clinton County line at a point approximately 1100 feet west of the S $\frac{1}{4}$ Corner of Section 31-T84N-R7E, Jackson County (N $\frac{1}{4}$ Corner of Section 6-T83N-R7E, Clinton County); thence in a northerly direction through sections 31, 30, 25 and 24-T84N-R7E to a point (junction Iowa 64) in the SE $\frac{1}{4}$ Section 24-T84N-R7E; thence in a northeasterly direction through Sections 24 and 19-T89N-R7E to a point near the center of Section 19-T89-R7E (junction US 52).
