New Description – US 69 and its extensions in Hancock County described as follows:

Beginning on the Hancock–Wright County line at a point near the SW Corner of Section 31–T94N–R23W, Hancock County (NW Corner of Section 6–T93N–R23W, Wright County); thence north following substantially the section line of said Section 31 to the south corporation line of Goodell connecting with an unnamed street.

Goodell:

Beginning on unnamed street at the south corporation line; thence north on unnamed street to the north corporation line.

Beginning again on the north corporation line of Goodell connecting with an unnamed street; thence north following substantially the section line of Sections 30, 19, 18, 7 and 6–T94N–R23W, Sections 31, 30, 19, 18, 7 and 6–T95N–R23W and Section 31–T96N–R23W to the south corporation line of Garner connecting with an unnamed street.

Garner:

Beginning on an unnamed street at the south corporation line; thence northerly on unnamed street to unnamed street (junction US 18); thence westerly on unnamed street to the west corporation line.

Beginning again on the west corporation line of Garner connecting with an unnamed street; thence west following substantially the center section line of Section 25–T96N–R24W to a point near the W ¼ Corner Section

25-T96N-R24W (west junction US 18); thence north following substantially the section line through Sections 25, 24, 13, 12 and 1-T96N-R24W, and Sections 36, 25, 24, 13, 12 and 11-T97N-R24W to the south corporation line of Forest City, connecting with an unnamed street.

Forest City:

Beginning on an unnamed street at the south corporation line; thence northerly and northeasterly on unnamed street to the Hancock-Winnebago County line (See Winnebago County).

#### **DISCUSSION/BACKGROUND:**

Due to a review of our Primary Road System records, US 69 in Hancock County should be deleted, and the new description added should be officially included into the Primary Road System.

US 69 begins at the Hancock-Wright County line, 1 mile south of Goodell, traveling in a northerly direction to the Hancock-Winnebago County line in Forest City via the cities of Goodell, Garner and Forest City, Iowa.

#### **PROPOSAL/ACTION RECOMMENDATION:**

Locate US 69 and its extensions in Hancock County as follows:

Beginning on the Hancock–Wright County line at a point near the SW Corner of Section 31–T94N–R23W, Hancock County (NW Corner of Section 6–T93N–R23W, Wright County); thence north following substantially the section line said Section 31 to the south corporation line of the City of Goodell connecting with an unnamed street.

Goodell:

Beginning on the south corporation line, connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Goodell connecting with an unnamed street; thence north following substantially the section line of Sections 30, 19, 18, 7 and 6–T94N–R23W, Sections 31, 30, 19, 18, 7 and 6–T95N–R23W and Section 31–T96N–R23W to the south corporation line of the City of Garner connecting with an unnamed street.

Garner:

Beginning on the south corporation line, connecting with an unnamed street; thence northerly and southwesterly to the west corporation line connecting with an unnamed street.

Beginning again on the west corporation line of the City of Garner connecting with an unnamed street; thence west following substantially the center section line of Section 25–T96N–R24W to a point near the W  $\frac{1}{4}$  Corner Section 25–T96N–R24W (west junction US 18); thence north following substantially the section line through Sections 25, 24, 13, 12 and 1–T96N–R24W, and Sections 36, 25, 24, 13, 12 and 11–T97N–R24W to the south corporation line of the City of Forest City, connecting with an unnamed street.

Forest City:

Beginning at the south corporation line connecting with an unnamed street thence northerly and northeasterly to the Hancock–Winnebago County line (See Winnebago County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 69 in Hancock County, Iowa.

NOTE: To become effective upon adoption of this resolution.

31-T96N-R23W; thence in a northeasterly direction to the south corporation line of the Town of Garner connecting with an unnamed street.

Garner:

Commencing on an unnamed street on the south corporation line; thence northerly on unnamed street to the intersection of Main Street (US 18); thence west on Main Street (US 18) to the west corporation line.

Beginning again on the west corporation line of the Town of Garner connecting with an unnamed street; thence west following substantially the quarter section line to a point approximately 600 feet east of the W  $\frac{1}{4}$  Corner Section 25-T96N-R24W; thence curving in a northwesterly direction to a point approximately 600 feet north of the W  $\frac{1}{4}$  Corner of Section 25-T96N-R24W; thence north following substantially the section line through Sections 25, 24, 13, 12 and 1-T96N-R24W, and Sections 36, 25, 24, 13 and 12-T97N-R24W to the south corporation line of the City of Forest City, connecting with an unnamed street.

Forest City:

Commencing on an unnamed street on the south Corporation line; thence north and northeasterly on unnamed street to a point on the Hancock-Winnebago County line approximately 500 feet east of the NW Corner of Section 1-T97N-R24W, Hancock County (SW Corner of Section 36-T98N-R24W, Winnebago County).

Beginning again on the north corporation line of the Town of Goodell connecting with an unnamed street on the west line of Section 30-T94N-R23W; thence north following substantially the section line to a point near the W  $\frac{1}{4}$  Corner of Section 31-T96N-R23W; thence in a northeasterly direction to the south corporation line of Garner, connecting with unnamed street.

Beginning again on the west corporation line of Garner, connecting with unnamed street; thence west following substantially the quarter section line to a point approximately 600 feet east of the W  $\frac{1}{4}$  Corner of Section 25-T96N-R24W; thence curving in a northwesterly direction to a point

approximately 600 feet north of the W ¼ Corner of Section 25–T96N–R24W; thence north following substantially the section line to a point near the SE Corner of Section 2–T97N–R24W; thence northwest to south corporation line of Forest City.
