New Description US 71 and its extensions in Montgomery County described as follows:

Beginning on the Montgomery-Page County line at a point near the SW Corner Section 34-T71N-R36W, Montgomery County (NW Corner Section 3-T70N-R36W, Page County); thence northerly and northwesterly through Sections 34, 33, and 28-T71N-R36W to the south corporation line of Villisca connecting with an unnamed street.

Villisca:

Beginning on an unnamed street at the south corporation line; thence north on said unnamed street to the north corporation line.

Beginning again at the north corporation line of Villisca, connecting with an unnamed street; thence in a northerly direction through the east part of Sections 21, 16, and 9-T71N-R36W and the west part of Sections 10 and 3-T71N-R36W (junction US 34) to a point near the W $\frac{1}{4}$ Corner of Section 3-T71N-R36W; thence northwesterly through Sections 4-T71N-R36W and 33, 28, 21, and 16-T72N-R36W to a point approximately 1,900 feet north of the SW Corner Section 15-T72N-R36W; thence in a northerly direction following substantially the section line of Sections 15, 10, and 3-T72N-R36W and 34, 27, 22, and 15-T73N-R36W to a point approximately 2,150 feet north of the SW Corner Section 15-T73N-R36W; thence in a northwesterly direction through Sections 16 and 9-T73N-R36W to the south corporation line of Grant, connecting with an unnamed street.

Grant:

Beginning on an unnamed street at the south corporation line; thence northerly on said unnamed street to the north corporation line.

Beginning again on the north corporation line of Grant, connecting with an unnamed street; thence in a northeasterly direction through Section 4-T73N-R36W to the Montgomery-Cass County line near the NE Corner Section 4-T73N-R36W, Montgomery County (SE Corner Section 33-T74N-R36W, Cass County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records US 71 in Montgomery County should be deleted and the new description added should be officially included into the Primary Road System.

US 71 begins on the Montgomery-Page County line approximately 2 miles south of Villisca and travels generally northerly via the City of Villisca and Grant to the Montgomery-Cass County line approximately 1 mile north of Grant, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 71 and its extensions in Montgomery County as follows:

Beginning on the Montgomery–Page County line at a point near the SE Corner Section 33–T71N–R36W, Montgomery County (NE Corner Section 4–T70N–R36W, Page County); thence northerly and northwesterly through Sections 34, 33, and 28–T71N–R36W to the south corporation line of the City of Villisca connecting with an unnamed street.

Villisca:

Beginning on the south corporation line, connecting with an unnamed street; thence in a northeasterly direction to the north corporation line, connecting with an unnamed street.

Beginning again at the north corporation line of the City of Villisca, connecting with an unnamed street; thence in a northerly direction through the east part of Sections 21, 16, and 9–T71N–R36W and the west part of Sections 10 and 3–T71N–R36W (junction US 34) to a point near the W $\frac{1}{4}$ Corner of Section 3–T71N–R36W; thence northeasterly through Sections 4–T71N–R36W and 33, 28, 21, and 16–T72N–R36W to a point approximately 1900 ft. north of the SW Corner Section 15–T72N–R36W; thence in a northerly direction following substantially the section line of Sections 15, 10, and 3–T72N–R36W and 34, 27, 22, and 15–T73N–R36W to a point approximately 2150 feet north of the SW Corner Section 15–T73N–R36W; thence in a northwesterly direction through Sections 16 and 9–T73N–R36W to the south corporation line of the City of Grant, connecting with an unnamed street.

Grant:

Beginning on the south corporation line connecting with an unnamed street; thence northwesterly and northeasterly to the north corporation line, connecting with an unnamed street.

Beginning again on the north corporation line of the City of Grant, connecting with an unnamed street; thence in a northeasterly direction through Section 4–T73N–R36W to the Montgomery–Cass County line near

the NE Corner Section 4-T73N-R36W, Montgomery County (SE Corner Section 33-T74N-R36W, Cass County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 71 in Montgomery County, Iowa.

NOTE: To become effective upon the adoption of this resolution.

TITLE: Approving Revision of US 71, Montgomery County, in the Primary Road System

Locate US 71 in Montgomery County, Iowa, as follows:

Beginning on the Montgomery-Page County line at a point near the SE Corner Section 33-T71N-R36W, Montgomery County (NE Corner Section 4-T70N-R36W, Page County); thence north following substantially the section line to a point near the E ¼ Corner Section 33-T71N-R36W; thence northwesterly and northerly to the south corporation line of Villisca, connecting with an unnamed street.

Villisca:

Beginning on an unnamed street at the south corporation line; thence northerly on said unnamed street to the north corporation line.

Beginning again on the north corporation line of Villisca, connecting with an unnamed street; thence northeasterly to a point near the NE Corner Section 21-T71N-R36W; thence north following substantially the section line to a point near the E ¼ Corner Section 4-T71N-R36W; thence in a northwesterly direction through Section 4-T71N-R36W; and in a northwesterly and northerly direction through Sections 33 and 28-T72N-R36W to a point approximately 700 feet east of the center of Section 28-T72N-R36W; thence in a northerly direction to a point approximately 600 feet east of the N ¼ Corner Section 28-T72N-R36W; thence in a northerly and northwesterly direction through Sections 21 and 16-T72N-R36W to a point approximately ¼ mile north of the SE Corner Section 16-T72N-R36W; thence north following substantially the section line to a point approximately 800 feet north of the E ¼ Corner Section 16-T73N-R36W; thence in a northwesterly direction to the south corporation line of Grant connecting with an unnamed street.

Grant:

Beginning on an unnamed street at the south corporation line; thence northerly on said unnamed street to the north corporation line.

Beginning on the north corporation line of Grant connecting with an unnamed street; thence in a northeasterly direction to the Montgomery-Cass County line near the NW Corner Section 3-T73N-R36W, Montgomery County (SW Corner Section 34-T74N-R36W, Cass County.)

NOW THEREFORE: Be it resolved that the Iowa State Highway Commission approve the revision of US 71 in Montgomery County, Iowa.

NOTE: The following sections of old US 71 will revert to the Montgomery County Secondary Road System in accordance with Section 313.2 Code of Iowa; ML Station 51+99.34 to Station 79+08, ML Station 574+88.33 to Station 875+05, and Station 915+40 to ML Station 670+36.29.

The sections of old US 71 located in Villisca – Station 79+08 to Station 129+89.44 ML and Grant – Station 875+05 to Station 915+40, will revert to the local street systems in accordance with Urban Policy 2600-001-E7.
