**DISCUSSION/BACKGROUND:**

Due to construction and realignment of US 71 just east of Fostoria in 1993, the official description of US 71 in Clay County should be changed in the Primary Road System to reflect this.

Transfer of jurisdiction agreement number 88-TJ-003 then transferred the old sections of US 71 to the City of Fostoria and Clay County on June 30, 1993.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the old description for US 71 in Clay County be deleted from the Primary Road System and the new description, as described in the attachment, be added to the Primary Road System.

New Description – US 71 and its extensions in Clay County described as follows:

Beginning on the Clay–Buena Vista County line at a point near the S  $\frac{1}{4}$  Corner of Section 36–T94N–R37W, Clay County (N  $\frac{1}{4}$  Corner of Section 1–T93N–R37W, Buena Vista County); thence north following substantially the center section line of Sections 36, 25, 24, 13, 12, and 1–T94N–R37W and Sections 36, 25, 24, 13, 12 and 1–T95N–R37W and Sections 36, 25, and 24–T96N–R37W to the south corporation line of Spencer connecting with an unnamed street.

Spencer:

Beginning on an unnamed street at the south corporation line; thence north on said unnamed street to the north corporation line.

Beginning again on the north corporation line of Spencer connecting with an unnamed street; thence north through the center of Section 24–T96N–R37W to a point near the W  $\frac{1}{4}$  Corner of the NE  $\frac{1}{4}$  of said Section 24 to the west corporation line of Spencer.

Spencer:

Beginning on an unnamed street at the west corporation line of Spencer; thence easterly on said unnamed street to Grand Avenue (south junction US 18); thence northerly on Grand Avenue to an unnamed street; thence northerly on an unnamed street to the north corporation line.

Beginning again on the north corporation line of Spencer connecting with an unnamed street; thence in a northwesterly direction through Section 30–T97N–R36W to a point approximately 1100 feet north of the SW Corner of Section 30–T97N–R36W; thence northerly following substantially the section line of Sections 30, 19 and 18–T97N–R36W; thence slightly northeasterly; thence northerly just east of west Section line of Sections 7 and 6–T97N–R36W; thence slightly northwesterly to near W  $\frac{1}{4}$  Corner Section 6–T97N–R36W; thence

northerly following substantially the section line of Section 6-T97N-R36W to a point near the NW Corner Section 6-T97N-R36W, Clay County (SW Corner Section 31-T98N-R36W, Dickinson County).

Beginning on the Clay-Buena Vista County line at a point near the S  $\frac{1}{4}$  Corner of Section 36-T94N-R37W, Clay County (N  $\frac{1}{4}$  Corner of Section 1-T93N-R37W, Buena Vista County); thence north following substantially the center section line of Sections 36, 25, 24, 13, 12, and 1-T94N-R37W and Sections 36, 25, 24, 13, 12, and 1-T95N-R37W and Sections 36, 25, and 24-T96N-R37W to the south corporation line of Spencer connecting with an unnamed street.

Spencer:

Beginning on an unnamed street at the south corporation line; thence north on said unnamed street to the north corporation line.

Beginning again on the north corporation line of Spencer connecting with an unnamed street; thence north through the center of Section 24-T96N-R37W to a point near the W  $\frac{1}{4}$  Corner of the NE  $\frac{1}{4}$  of said Section 24 to the west corporation line of Spencer.

Spencer:

Beginning on an unnamed street at the west corporation line of Spencer; thence easterly on said unnamed street to Grand Avenue (south junction US 18); thence northerly on Grand Avenue to an unnamed street; thence northerly on an unnamed street to the north corporation line.

Beginning again on the north corporation line of Spencer connecting with an unnamed street; thence in a northwesterly direction through Section 30-T97N-R36W to a point approximately 1100 feet north of the SW Corner of Section 30-T97N-R36W; thence northerly following substantially the section line of Sections 30, 19, 18, and 7-T97N-R36W to the south corporation line of Fostoria connecting with an unnamed street.

Fostoria:

Beginning at the south corporation line connecting with an unnamed street; thence north to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of Fostoria connecting with an unnamed street; thence north following substantially the section line of Section 6-T97N-R36W to a point near the NW Corner Section 6-T97N-R36W, Clay County (SW Corner of Section 31-T98N-R36W, Dickinson County).

Due to the review of our Primary road System records, US 71 in Clay County should be deleted from the Primary System and the new description added should be officially included into the Primary Road System.

Beginning on the Clay-Buena Vista County line at a point near the S ¼ Corner of Section 36-T94N-R37W, Clay County (N ¼ Corner of Section 1-T93N-R37W, Buena Vista County; thence north following substantially the center section line of Section 36, 25, 24, 13, 12, and 1-T94N-R37W and Section 36, 25, 24, 13, 12, and 1-T95N-R37W and Sections 36, 25, and 24-T96N-R37W to the west corporation line of the City of Spencer connecting with an unnamed street.

Spencer:

Beginning on the west corporation line connecting with an unnamed street; thence easterly and northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Spencer connecting with unnamed street; thence in a northwesterly direction through Section 30-T97N-R36W to a point approximately 1100 feet north of the SW Corner of Section 30-T97N-R36W; thence northerly following substantially the section line of Sections 30, 19, 18, and 7-T97N-R36W to the south corporation line of the City of Fostoria connecting with an unnamed street.

Fostoria:

Beginning at the south corporation line connecting with an unnamed street; thence north to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Fostoria connecting with an unnamed street; thence north following substantially the section line of Section 6-T97N-R36W to a point near the NW Corner Section 6-T97N-R36W, Clay County (SW Corner of Section 31-T98N-R36W, Dickinson County).

Beginning on the west corporation line connecting with an unnamed street; thence easterly and northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Spencer connecting with unnamed street; thence in a northwesterly direction through Section 30-T97N-R36W to a point approximately 1100 feet north of the SW Corner of Section 30-T97N-R36W; thence northerly following substantially the section line of Sections 30, 19, 18, and 7-T97N-R36W to the south corporation line of the City of Fostoria connecting with an unnamed street.

Fostoria:

Beginning at the south corporation line connecting with an unnamed street; thence north to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Fostoria connecting with an unnamed street; thence north following substantially the section line of Section 6-T97N-R36W to a point near the NW Corner Section 6-T97N-R36W, Clay County (SW Corner of Section 31-T98N-R36W, Dickinson County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 18 in Clay County, Iowa.
