Beginning on the Cass–Montgomery County line, at a point near the SE Corner Section 33–T74N–R36W, Cass County (NE Corner Section 4–T73N–R36W, Montgomery County); thence northeasterly through said Section 33 to a point approximately 300 feet north of the SW Corner Section 34–T74N–R36W; thence north following substantially the section line through Sections 34, 27, 22, 15 and 10–T74N–R36W to a point approximately 1,150 feet north of the SW Corner Section 10–T74N–R36W; thence northwesterly & northeasterly through Sections 9 (south junction Iowa 92) and 4–T74N–R36W and Sections 33 (north junction Iowa 92), 28 and 21–T75N–R36W to a point approximately 400 feet south of the NE Corner said Section 21; thence north through Sections 22, 15, 9 and 4–T75N–R36W and Sections 33, 28, 27, 22, 21, 15 and 10–T76N–R36W (south junction US 6 and west junction Iowa 83) to a point near the NW Corner said Section 10; thence east following substantially the section line Sections 10 and 11–T76N–R36W to a point near the NE Corner said Section 11 (east junction Iowa 83); thence north following substantially the section line of Section 1–T76N–R36W and Sections 36, 25, 24, 13, 12 and 1–T77N–R36W (junction Interstate 80 and north junction US 6) to the Cass–Audubon County line at a point near the NW Corner Section 1–T77N–R36W, Cass County (SE Corner Section 36–T78N–R36W, Audubon County).

Due to a review of our Primary Road System records, US 71 in Cass County should be deleted, and the new description added should be officially included into the Primary Road System.

US 71 begins at the Cass-Montgomery County line approximately 15 miles south of Atlantic, Iowa and travels in a northeasterly direction to the Cass-Audubon County line approximately 8 miles northeast of Atlantic, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 71 in Cass County as follows:

Beginning on the Cass-Montgomery County line, at a point near the SW Corner Section 34-T74N-R36W, Cass County (NW Corner Section 3-T73N-R36W, Montgomery County); thence north following substantially the section line through Sections 34, 27, 22, 15 and 10-T74N-R36W to a point approximately 1,150 feet south of the NW Corner of Section 10-T74N-R36W; thence curving northwesterly, northeasterly through Section 9, 4 and 3-T74N-R36W to the NW Corner Section 3-T74N-R36W; thence north following substantially the section line of Sections 34, 27, 22, 15, 10 and 3-T75N-R36W and Sections 34, 27, 22, 15 and 10-T76N-R36W (west junction US 6 and Iowa 83); thence east following substantially the section line of Sections 10 and 11-T76N-R36W (east junction US 6 and Iowa 83) to a point approximately 1,000 feet west of the NE Corner Section 11-T76N-R36W; thence curving in a northeasterly direction to a point approximately 1,000 feet north of the SW Corner Section 2-T76N-R36W; thence north following substantially the section line of Section 1-T76N-R36W and Sections 36, 25, 24, 13, 12

and 1-T77N-R36W (Interstate 80 Interchange) to a point on the Cass-Audubon County line near the NW Corner of said Section 1-T77N-R36W; Cass County (SE Corner Section 36-T78N-R36W, Audubon County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 71, Cass County, Iowa.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 71, Cass County, Iowa.

Beginning at a point approximately 700 feet south of the NW Cor. Sec. 34-T75-R36, thence curving in a northeasterly direction to a point approximately 700 feet east of the NW Cor. Sec. 34-T75-R36.

East Junction of Primary Road No. US 6 and Primary Road No. US 71.

Beginning at a point approximately 1000 feet east of the SW Cor. Sec. 1-T76-R36, thence curving in a northwesterly direction to a point approximately 1000 feet north of the SW Cor.
