TITLE: Official Description Change: US 75, Monona County

DISCUSSION/BACKGROUND:

US 75 begins on Interstate 29 on the Harrison-Monona County line approximately 2 miles east of the Missouri River and travels northerly and northwesterly on Interstate 29 to the Monona-Woodbury County line approximately 6 miles east of the Missouri River.

US 75 has been relocated in the State of Nebraska from the Omaha-Council Bluffs area to proceed northerly in Nebraska entering Iowa running duplicate with Interstate 129 at Sioux City. In cooperation with the State of Nebraska the description of US 75 in Monona County should be removed from the Primary Road System to reflect this relocation.

PROPOSAL/ACTION RECOMMENDATION:

It is recommended to approve deleting the present description of US 75 in Monona County from the Primary Road System.

Remove US 75 in Monona County described as follows:

Beginning on Interstate 29 at the Monona–Harrison County line near the S $\frac{1}{4}$ Corner of the SE $\frac{1}{4}$ Section 32–T82N–R45W, Monona County (N $\frac{1}{4}$ Corner of the NE $\frac{1}{4}$ Section 5–T81N–R45W, Harrison County); thence northerly, northwesterly and northerly on Interstate 29 to the Monona–Woodbury County line at a point 187 feet east of the N $\frac{1}{4}$ Corner Section 6–T85N–R46W, Monona County (S $\frac{1}{4}$ Corner Section 31–T86N–R46W, Woodbury County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, US 75 in Monona County should be deleted and the new description added should be officially included into the Primary System.

US 75 begins on Interstate 29 on the Harrison–Monona County line approximately 2 miles east of the Missouri River and travels northerly and northwesterly on Interstate 29 to the Monona–Woodbury County line approximately 6 miles east of the Missouri River.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 75 in Monona County as follows:

Beginning on Interstate 29 at the Monona–Harrison County line near the S $\frac{1}{4}$ Corner of the SE $\frac{1}{4}$ Section 32–T82N–R45W Monona County (N $\frac{1}{4}$ Corner of the NE $\frac{1}{4}$ Section 5–T81N–R45W, Harrison County); thence northerly, northwesterly and northerly on Interstate 29 to the Monona–Woodbury County line at a point 187 feet east of the N $\frac{1}{4}$ Corner Section 6–T85N–R46W, Monona County (S $\frac{1}{4}$ Corner Section 31–T86N–R46W, Woodbury County).

NOTE: See Interstate 29.

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 75 in Monona County, Iowa.

TITLE: US 75 in Monona County

Locate US 75 in Monona County, Iowa, as follows:

Beginning on Interstate 29 at the Monona-Harrison county line-near the SE Corner Section 32-T82N-R45W, Monona County (NE Corner Section 5-T81N-R45W, Harrison County); thence northerly, northwesterly, and northerly on Interstate 29 to the Monona-Woodbury County line near the N ¼ Corner Section 6-T85N-R46W, Monona County (S ¼ Corner Section 31-T86N-R46W, Woodbury County).

NOW THEREFORE: Be it resolved that the Iowa State Highway Commission approve the revision of US 75 in Monona County, Iowa.

NOTE: To become effective upon adoption of this resolution. The old location of US 75 from the Monona-Harrison County line north to the south corporation line Onawa will revert to Monona County as per agreement dated March 20, 1968. From the south corporation line of Onawa northerly to Iowa 175 will revert to city street system in accord with urban policy 2600-001-E7. From Iowa 175 north to the Monona-Woodbury County line will become Iowa 475.
