

## DISCUSSION/BACKGROUND:

Due to an annexation by the City of Adel effective April 23, 2018, it is recommended that the primary route description for US 169 in Dallas County be revised.

New Description - US 169 and its extensions in Dallas County described as follows:

Beginning on the Dallas-Madison County line near the SW Corner Section 31-T78N-R27W, Dallas County (NW Corner Section 6-T77N-R27W, Madison County); thence north following substantially the section line of Section 31 and 30-T78N-R27W to the south corporation line of De Soto connecting with Guthrie Street.

De Soto:

Beginning on Guthrie Street at the south corporation line; thence north on Guthrie Street to the north corporation line.

Beginning again on the north corporation line of De Soto connecting with Guthrie Street; thence north following substantially the section line of Sections 19, 16, 7, and 6-T78N-R27W to the south corporation line of Adel connecting with Nile Kinnick Drive South.

#### Adel:


Beginning at the south corporation line connecting with Nile Kinnick Drive South; thence northerly on Nile Kinnick Drive South to the north corporation line at the intersection of 302<sup>nd</sup> Place.

Beginning again at the north corporation line of Adel connecting with Nile Kinnick Drive South; thence northerly to the south corporation line of Adel connecting with Nile Kinnick Drive South (approximately 70 feet west of the NW Corner of Section 6-T78N-R27W).

#### Adel:

Beginning on Nile Kinnick Drive South at the south corporation line; thence northwest and north on Nile Kinnick Drive South connecting with Nile Kinnick Drive North to the north corporation line.

Beginning again on the north corporation line of Adel connecting with Nile Kinnick Drive North; thence north through Section 29–T79N–R27W and northwest and north through the west part of Sections 20, 17, 8, and 5–T79N–R27W (junction lowa 44) and Sections 32–T80N–R27W, to the south corporation line of Dallas Center connecting with N Avenue.



Dallas Center:

Beginning at the south corporation line connecting with N Avenue; thence north on N Avenue to the north corporation line.

Beginning again at the north corporation line of Dallas Center connecting with N Avenue; thence north through Sections 32 and 29–T80N–R27W to a point approximately 600 feet south of the W ¼ Corner of Section 20–T80N–R27W; thence north following substantially the section line of Sections 20, 17, and 8–T80N–R27W to the south corporation line of Minburn connecting with 4<sup>th</sup> street.

#### Minburn:

Beginning on 4<sup>th</sup> street at the south corporation line; thence north on 4<sup>th</sup> street to the north corporation line.

Beginning again on the north corporation line of Minburn connecting with 4<sup>th</sup> street; thence north following substantially the section line of Section 5–T80N–R27W and Sections 32, 29, 20, 17, 8 (junction lowa 141) and 5–T81N–R27W to the Dallas–Boone County line at a point near the NW Corner Section 5–T81N–R27W, Dallas County (SW Corner of Section 32–T82N–R27W, Boone County).

#### De Soto:

Beginning on Guthrie Street at the south corporation line; thence north on Guthrie Street to the north corporation line.

Beginning again on the north corporation line of De Soto connecting with Guthrie Street; thence north following substantially the section line of Sections 19, 16, 7, and 6-T78N-R27W to a point approximately 950 feet south of the NW Corner Section 6-T78N-R27W; thence northwest through Section 1-T78N-R28W to the south corporation line of Adel connecting with 8th Street.

## Adel:

Beginning on 8th Street at the south corporation line; thence northwest and north on 8th Street to the north corporation line.

Beginning again on the north corporation line of Adel connecting with 8th Street; thence north through Section 29–T79N–R27W and northwest and north through the west part of Sections 20, 17, 8, and 5–T79N–R27W (junction lowa 44) and Sections 32, 29, and 20–T80N–R27W, to a point approximately 600 feet south of the W ¼ Corner of Section 20–T80N–R27W; thence north following substantially the section line of Sections 20, 17, and 8–T80N–R27W to the south corporation line of Minburn connecting with an unnamed street.

#### Minburn:

Beginning on an unnamed street at the south corporation line; thence north on unnamed street to the north corporation line.

Beginning again on the north corporation line of Minburn connecting with an unnamed street; thence north following substantially the section line of Section

5-T80N-R27W and Sections 32, 29, 20, 17, 8 (junction Iowa 141) and 5-T81N-R27W to the Dallas-Boone County line at a point near the NW Corner Section 5-T81N-R27W, Dallas County (SW Corner of Section 32-T82N-R27W, Boone County).

# **DISCUSSION/BACKGROUND:**

US 169 begins at the Dallas-Madison County line approximately 2 miles south of De Soto, Iowa and travels northerly via De Soto, Adel, and Minburn, Iowa to the Dallas-Boone County line approximately 4 miles northeast of Perry, Iowa.

Due to a review of our Primary Road System Records US 169 in Dallas County should be deleted and the new description added should be officially included into the Primary System.

#### PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of US 169 in Dallas County be deleted and the new description, as referred in the attached detailed description, be included in the Primary Road System effective upon the adoption of this resolution.

Locate US 169 and its extensions in Dallas County as follows:

Beginning on the Dallas-Madison County line near the SW Corner Section 31-T78N-R27W, Dallas County (NW Corner Section 6-T77N-R27W, Madison County); thence northerly following substantially the section line of Sections 31 and 30-T78N-R27W to the south corporation line of the City of De Soto connecting with an unnamed street.

#### De Soto:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of De Soto connecting with an unnamed street; thence north following substantially the section line of Sections 19, 18, 7, and 6–T78N–R27W to a point approximately 950 feet south of the NW Corner Section 6–T78N–R27W; thence northwesterly through Section 1–T78N–R28W to the south corporation line of the City of Adel connecting with an unnamed street.

### Adel:

Beginning at the south corporation line connecting with an unnamed street; thence northwesterly and northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Adel connecting with an unnamed street; thence in a northerly direction through Section 29-T79N-R27W and in a northwesterly and northerly direction through the west part of Sections 20, 17, 8, and 5-T79N-R27W (junction lowa 44) and Sections 32, 29, and 20-T80N-R27W, to a point approximately 600 feet south of the W ¼ Corner of Section 20-T80N-R27W; thence north following substantially the section line of Sections 20, 17 and 8-T80N-R27W to the south corporation line of the City of Minburn connecting with unnamed street.

#### Minburn:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Minburn connecting with unnamed street; thence north following substantially the section line of Section 5–T80N–R27W and Sections 32, 29, 20, 17, 8 (junction lowa 141) and 5–T81N–R27W to the Dallas–Boone County line at a point near the NW Corner Section 5–T81N–R27W, Dallas County (SW Corner of Section 32–T82N–R27W, Boone County).

# **DISCUSSION/BACKGROUND:**

Due to the review of our Primary Road System records, US 169 in Dallas County should be deleted from the Primary System and the new description added should be officially included into the Primary Road System.

US 169 begins at the Dallas-Madison County line approximately 2 miles south of De Soto, Iowa and travels northerly via De Soto, Adel, and Minburn, Iowa to the Dallas-Boone County line approximately 4 miles northeast of Perry, Iowa.

## PROPOSAL/ACTION RECOMMENDATION:

Locate US 169 and its extension in Dallas County as follows:

Beginning on the Dallas-Madison County line near the SW Corner Section 31—T78N-R27W, Dallas County (NW Corner Section 6-T77N-R27W, Madison County); thence northerly following substantially the section line of Section 31 (junction of Iowa 90) and 30-T78N-R27W to the south corporation line of the City of De Soto connecting with an unnamed street.

De Soto:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of De Soto connecting with an unnamed street; thence north following substantially the section line of Section 19 (Interstate 80 interchange), 18, 7, 6–T78N–R27W to a point approximately 950 feet south of the NW Corner Section 6–T78N–R27W; thence northwesterly through Section 1–T78N–R28W to the south corporation line of the City of Adel connecting with an unnamed street.

## Adel:

Beginning at the south corporation line connecting with an unnamed street; thence northwesterly and northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Adel connecting with an unnamed street; thence in a northerly direction through Section 29–T79N–R27W and in a northwesterly and northerly direction through the west part of Sections 20, 17, 8, and 5–T79N–R27W (junction lowa 44) and Sections 32, 29, and 20–T80N–R27W, to a point approximately 600 feet south of the W ¼ Corner of Section 20–T80N–R27W; thence north following substantially the section line of Section 17 and 8–T80N–R27W to the south corporation line of the City of Minburn connecting with unnamed street.

#### Minburn:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again on the north corporation line of the City of Minburn connecting with unnamed street; thence north following substantially the section line of Section 5-T80N-R27W and Sections 32, 29, 20, and 17-T81N-R27W (junction lowa 141) and Sections 8 and 5-T81-R27W to the Dallas-Boone County line at a point near the NW Corner Section 5-T81N-R27W, Dallas County (SW Corner of Section 32-T82N-R27W, Boone County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 169 in Dallas County, Iowa.

A connecting road beginning at a point approximately 2000 feet east of the SW Corner of Section 32–T80N–R27W; thence curving in a northwesterly direction to a point approximately 1200 feet east and 800 feet north of the SW Corner of Section 32–T80N–R27W.

Also

A connecting road beginning at a point approximately 2000 feet east of the NW Corner of Section 5-T79N-R27W; thence curving in a southwesterly direction to a point approximately 1200 feet east and 800 feet south of the NW Corner of Section 5-T79N-R27W.
