Beginning at the Boone–Dallas County line at a point near the SW Corner Section 32–T82N–R27W, Boone County (NW Corner Section 5–T81N–R27W, Dallas County); thence north following substantially the section line of Sections 32, 29, 20, 17, 8, and 5–T82N–R27W continuing north following substantially the section line of Sections 32, 29, 20, 17, 8, and 5–T83N–R27W to a point approximately 100 feet south of the E $\frac{1}{4}$ Corner Section 6–T83N–R27W (east junction of US 30); thence westerly through Section 6–T83N–R27W to a point near the center of Section 6–T83N–R27W; thence northwesterly through Section 6–T83N–R27W and Section 1–T83N–R28W to a point approximately 526 feet east of the N $\frac{1}{4}$ Corner Section 1–T83N–R28W; thence west following substantially the section line of Sections 1, 2, 3–T83N–R28W to a point near the NW Corner of Sec 3–T83N–R28W (west junction of US 30); thence north following substantially the section line of Sections 34, 27, 22, 15, 10, 3–T84N–R28W continuing north following substantially the section line of Sections 34, 27, and 22–T85N–R26W to the south corporation line of the City of Boxholm connecting with Beech Street.

Boxholm:

Beginning on Beech Street at the south corporation line; thence north on Beech Street to the north corporation line.

Beginning again at the north corporation line of Boxholm, connecting with Beech Street; thence north following substantially the section line of Sections 10 and 3–T85N–R28W to the Boone–Webster County line at a

point near the NW Corner of Section 3–T85N–R28W, Boone County (SW Corner Section 34–T86N–R28W, Webster County).

DISCUSSION/BACKGROUND:

Due to a review of the Primary Road System Records, US 169 in Boone County should be deleted and the new description added should be officially included into the Primary System.

US 169 begins at the Boone–Dallas County line approximately 5 miles west of Woodward and travels northerly to the east junction of US 30; thence westerly to the west junction of US 30; thence northerly through the City of Boxholm to the Boone–Webster County line approximately 2 miles north of Boxholm.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 169 and its extension in Boone County as follows:

Beginning at the Boone–Dallas County line at a point near the SW Corner Section 32–T82N–R27W, Boone County (NW Corner Section 5–T81N–R27W, Dallas County); thence north following substantially the section line of Sections 32, 29, 20, 17, 8, and 5–T82N–R27W continuing northerly following substantially the section line of Sections 32, 29, 20, 17, 8, and 5–T83N–R27W to a point approximately 100 feet south of the E ¼ Corner Section 6–T83N–R27W (east junction of US 30); thence

westerly through Section 6-T83N-R27W to a point near the center of Section 6-T83N-R27W; thence northwesterly through Section 6-T83N-R27W and Section 1-T83N-R28W to a point approximately 526 feet east of the N $\frac{1}{4}$ Corner Section 1-T83N-R28W; thence west following substantially the section line of Sections 1, 2, 3-T83N-R28W to a point near the NW Corner of Section 3-T83N-R28W (west junction of US 30); thence north following substantially the section line of Sections 34, 27, 22, 15, 10, 3-T84N-R28W continuing north following substantially the section line of Sections 34, 27, and 22-T85N-R28W to the south corporation line of the City of Boxholm connecting with an unnamed street.

Boxholm:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of Boxholm, connecting with an unnamed street; thence northerly following substantially the section line of Sections 10 and 3-T85N-R28W to the Boone-Webster County line at a point near the NW Corner of Section 3-T85N-R28W, Boone County (SW Corner Section 34-T86N-R28W, Webster County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 169 in Boone County, Iowa.

DISCUSSION/BACKGROUND:

section line of Sections 34, 27, and 22–T85N–R28W to the south corporation line of the City of Boxholm connecting with an unnamed street.

Boxholm:

Beginning at the south corporation line connecting with an unnamed street; thence northerly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of Boxholm, connecting with an unnamed street; thence northerly following substantially the section line of Sections 10 and 3–T85N–R28W to the Boone–Webster County line at a point near the NW Corner of Section 3–T85N–R28W, Boone County (SW Corner Section 34–T86N–R28W, Webster County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 169 in Boone County, Iowa.
