New Description – US 218 and its extensions in Floyd County described as follows:

Beginning at the Floyd-Chickasaw County line at a point near the NE Corner Section 13-T94N-R15W, Floyd County (NW Corner Section 18-T94N-R14W, Chickasaw County); thence in a northwesterly direction through Sections 12, 11, 2, and 3-T94N-R15W to a point approximately 1000 feet west of the SE Corner Section 34-T95N-R15W; thence continuing northwesterly through Sections 34, 33, 28, and 29-T95N-R15W to a point approximately 1060 feet east of NW Corner Section 29-T95N-R15W; thence northerly and northwesterly through Section 20 and 19-T95N-R15W to approximately 1000 feet west of the NE Corner Section 19-T95N-R15W; thence northerly and westerly through 18-T95N-R15W to the east corporation line of Charles City (approximately 200 feet north of the S $\frac{1}{4}$ Corner Section 18-T95N-R15W) connecting with unnamed street.

Charles City:

Beginning at the east corporation line (approximately 200 feet north of the S $\frac{1}{4}$ Corner Section 18-T95N-R15W) connecting with unnamed street; thence westerly to the west corporation line of Charles City (approximately 200 feet north of SW Corner Section 18-T95N-R15W).

Beginning again at the west corporation line of Charles City (approximately 200 feet north of SW Corner Section 18-T95N-R15W) connecting with unnamed street; thence westerly through 13 and 14-

T95N-R16W; thence northwesterly and northerly through Sections 15 and 10-T95N-R16W connecting with south junction US 18 (approximately 1350 feet west of E ¼ Corner Section 10-T95N-R16W); thence northerly on US 18 through Sections 10 and 3-T95N-R16W and northwesterly through Section 34, 27, 22, and 21-T96N-R16W to the north junction US 18; thence easterly and northeasterly through Section 21-T96N-R16W to the south corporation line of Floyd, connecting with Monroe Street.

Floyd:

Beginning on the south corporation line, connecting with Monroe Street; thence northerly and northeasterly to the north corporation line (approximately 450 feet west of the E ¼ Corner Section 16-T96N-R16W).

Beginning at the north corporation line of Floyd, connecting with Monroe Street (approximately 450 feet west of the E ¼ Corner Section 16-T96N-R16W); thence northeasterly through Section 16-T96N-R16W to a point approximately 350 feet south to the NE Corner of said Section 16; thence north following substantially the section line of Sections 15, 10, and 3-T96N-R16W and Sections 34, 27, and 22-T97N-R16W to the Floyd-Mitchell County line at a point near the NE Corner Section 21-T97N-R16W, Floyd County (SE Corner Section 16-T97N-R16W, Mitchell County).

PROPOSAL/ACTION RECOMMENDATION:

It is recommended that the old description of US 218 and its extensions in Floyd County be deleted and the new description be included in the Primary Road System.

New Description- US 218 and its extensions in Floyd County described as follows:

Beginning at the Floyd-Chickasaw County line at a point near the NE Corner Section 13-T94N-R15W, Floyd County (NW Corner Section 18-T94N-R14W, Chickasaw County); thence in a northwesterly direction through Sections 12, 11, 2, and 3-T94N-R15W to a point approximately 1000 feet west of the SE Corner Section 34-T95N-R15W; thence continuing northwesterly through Sections 34, 33, 28, and 29-T95N-R15W to a point approximately 1060 feet east of NW Corner Section 29-T95N-R15W; thence northerly and northwesterly through Section 20 and 19-T95N-R15W to approximately 1000 feet west of the NE Corner Section 19-T95N-R15W; thence northerly and westerly through 18-T95N-R15W to the east corporation line of Charles City (approximately 200 feet north of the S $\frac{1}{4}$ Corner Section 18-T95N-R15W) connecting with unnamed street.

Charles City:

Beginning at the east corporation line (approximately 200 feet north of the S $\frac{1}{4}$ Corner Section 18-T95N-R15W) connecting with unnamed street; thence westerly to the west corporation line of Charles City (approximately 200 feet north of SW Corner Section 18-T95N-R15W).

Beginning again at the west corporation line of Charles City (approximately 200 feet north of SW Corner Section 18-T95N-R15W) connecting with unnamed street; thence easterly through 13 and 14-T95N-R16W; thence northeasterly and northerly through Sections 15 and 10-T95N-R16W connecting with south junction US 18 (approximately 1350 feet west of E $\frac{1}{4}$ Corner Section 10-T95N-R16W); thence northerly

on US 18 through Sections 10 and 3-T95N-R16W; and northeasterly through Section 34, 27, 22, and 21-T96N-R16W to the north junction US 18; thence easterly and northeasterly through Section 21-T96N-R16W to the south corporation line of Floyd connecting with Monroe Street.

Floyd:

Beginning at the south corporation line connecting with Monroe Street; thence northerly and northeasterly to the north corporation line (approximately 450 feet west of E ¼ Corner Section 16-T96N-R16W).

Beginning at the north corporation line of the City of Floyd, connecting with Monroe Street (approximately 450 feet west of E ¼ Corner Section 16-T96N-R16W); thence northeasterly through Section 16-T96N-R16W to a point approximately 350 feet south to the NE Corner of said Section 16; thence north following substantially the section line of Sections 15, 10, and 3-T96N-R16W and Sections 34, 27, and 22-T97N-R16W to the Floyd-Mitchell County line at a point near the NE Corner Section 21-T97N-R16W, Floyd County (SE Corner Section 16-T97N-R16W, Mitchell County).

PROPOSAL/ACTION RECOMMENDATION:

Beginning at the Floyd–Chickasaw County line at a point near the NE Corner Section 13–T94N–R15W, Floyd County (NW Corner Section 18–T94N–R14W, Chickasaw County); thence in a northwesterly direction through Sections 12, 11, 2, and 3–T94N–R15W to a point approximately 1,000 feet west of the SE Corner Section 34–T95N–R15W, and continuing northwesterly through Sections 34, 33, 32, 29, 20, 17, and 18–T95N–R15W to a point approximately 400 feet south of the NW Corner Section 18–T95N–R15W; thence northerly following substantially the section line of Section 18–T95N–R15W to the south corporation line of Charles City connecting with Grand Avenue.

Charles City:

Beginning on Grand Avenue at the south corporation line; thence northerly on Grand Avenue to 5th Street; thence northwesterly on an unnamed street to Gilbert Street; thence northwesterly on Gilbert Street to the west corporation line.

Beginning again at the west corporation line of Charles City connecting with Gilbert Street; thence in a northwesterly direction through Section 2–T95N–R16W and Sections 35, 34, 27, 22, and 21, T96N–R16W (north junction of US 18) to a point approximately 2,100 feet south and 1,200 feet west of the NE Corner of Section 21–T96N–R16W; thence north through said Section 21 to the south corporation line of Floyd, connecting with Monroe Street.

Floyd:

Beginning at the south corporation line on Monroe Street; thence northerly and northeasterly on Monroe Street to the north corporation line.

Beginning again at the north corporation line of the City of Floyd, connecting with Monroe Street; thence northeasterly through Section 16-T96N-R16W to a point approximately 350 feet south of the NE Corner of said Section 16; thence north following substantially the section line of Sections 15, 10 and 3-T96N-R16W and Sections 34, 27, and 22-T97N-R16W to the Floyd-Mitchell County line at a point near the NE Corner of Section 21-T97N-R16W, Floyd County (SE Corner Section 16-T97N-R16W, Mitchell County).

DISCUSSION/BACKGROUND:

Due to a review of our Primary Road System records, US 218 in Floyd County, Iowa should be deleted and the new description added should be officially included into the Primary System.

US 218 begins at the Floyd-Chickasaw County line approximately ½ mile north of Nashua and travels in a northwesterly direction via the cities of Charles City and Floyd to the Floyd-Mitchell County line approximately 5 ½ miles north of Floyd, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 218 and its extensions in Floyd County as follows:

Beginning at the Floyd–Chickasaw County line at a point near the NE Corner Section 13–T94N–R11W, Floyd County (NW Corner Section 18–T94N–R14W, Chickasaw County); thence in a northwesterly direction through Sections 12, 11, 2, and 3–T94N–R15W to a point approximately 1,000 feet west of the SE Corner Section 34–T95N–R15W, and continuing northwesterly through Sections 34, 33, 28, 29, 20, 17, and 18–T95N–R15W to a point approximately 400 feet south of the NW Corner Section 18–T95N–R15W; thence northerly following substantially the section line of Section 18–T95N–R15W to the south corporation line of the City of Charles City connecting with an unnamed street.

Charles City:

Beginning at the south corporation line connecting with an unnamed street; thence northerly and northwesterly to the west corporation line connecting with an unnamed street.

Beginning again at the west corporation line of the City of Charles City connecting with an unnamed street; thence in a northwesterly direction through Section 2–T95N–R16W and Sections 35, 34, 27, 22, and 21, T96N–R16W (north junction of US 18) to a point approximately 2,100 feet south and 1,200 feet west of the NE Corner of Section 21–T96N–R16W; thence north through said Section 21 to the south corporation line of the City of Floyd, connecting with an unnamed street.

Floyd:

Beginning at the south corporation line connecting with an unnamed street; thence northerly and northeasterly to the north corporation line connecting with an unnamed street.

Beginning again at the north corporation line of the City of Floyd, connecting with an unnamed street; thence northeasterly through Section 16–T96N–R16W to a point approximately 350 feet south of the NE Corner said Section 16; thence north following substantially the section line of

Sections 15, 10 and 3-T96N-R16W and Sections 34, 27, and 22-T97N-R16W to the Floyd-Mitchell County line at a point near the NE Corner of Section 21-T97N-R16W, Floyd County (SE Corner Section 16-T97N-R16W, Mitchell County).

NOW, THEREFORE: Be it resolved that the Iowa Department of Transportation approve the location of US 218 in Floyd County, Iowa.

NOTE: To become effective upon the adoption of this resolution.

Beginning again on the west corporation line of the City of Charles City, connecting with Gilbert Street; thence in a northwesterly direction through Section 2-T95N-R16W and Sections 35, 34, 27, 22 and 21-T96N-R16W to a point approximately 2,100 ft. south and 1,200 ft. west of the NE Corner of Section 21-T96N-R16W; thence north to the south corporation line of the Town of Floyd, connecting with Monroe Street.

Beginning again on the north corporation line of the Town of Floyd, connecting with Monroe Street; thence in a northeasterly direction to a point near the NE Corner of Section 16–T96N–R16W; thence north following substantially the section line to the Floyd–Mitchell County line at a point near the NE Corner of Section 21–T97N–R16W Floyd County (SE Corner Section 16–T97N–R16W Mitchell County).
