New Description – US 218 and its extensions in Bremer County described as follows:

Janesville:

Beginning at the S  $\frac{1}{4}$  Corner SW  $\frac{1}{4}$  of Section 36-T91N-R14W, Bremer County (N  $\frac{1}{4}$  Corner NW  $\frac{1}{4}$  of Section 1-T90N-R14W, Black Hawk County); thence in a northerly and northwesterly direction to the north corporation line (approximately 1280 feet east and 370 feet south of the NW Corner of Section 35-T91N-R14W).

Beginning again on the north corporation line of Janesville (approximately 1280 feet east and 370 feet south of the NW Corner of Section 35-T91N-R14W); thence in a northerly and northwesterly direction through Sections 35, 26, and 23-T91N-R14W to a point near the W  $\frac{1}{4}$  Corner of Section 23-T91N-R14W; thence north following substantially the section line of Sections 23 and 14-T91N-R14W to approximately 680 feet north of the SW Corner of Section 14-T91N-R14W; thence curving northwesterly through Section 15-T91N-R14W to the W  $\frac{1}{4}$  Corner of Section 15-T91N-R14W; thence west following substantially the center section line of Sections 16 and 17-T91N-R14W to near the Center of Section 17-T91N-R14W; thence curving northwesterly to near the NW Corner of Section 17-T91N-R14W; thence northerly following substantially the section line of Sections 8 and 5-T91N-R14W and Sections 32, 29, 20, 17, 8, and 5-T92N-R14W and Section 32-T93N-R14W to a point near the W  $\frac{1}{4}$  Corner of Section 32-T93N-R14W; thence northwesterly through Sections 31 and 30-T93N-R14W to near the N  $\frac{1}{4}$  Corner of Section 30-T93N-R14W; thence north following substantially the center section line of Sections 19, 18, and 7-T93N-

R14W to near the Center of Section 7-T93N-R14W; thence northwesterly and northeasterly through Sections 7 and 6-T93N-R14W to the Bremer-Chickasaw County line near the N  $\frac{1}{4}$  Corner of Section 6-T93N-R14W, Bremer County (S  $\frac{1}{4}$  Corner of Section 31-T94N-R14W, Chickasaw County).

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended that the old description of US 218 and its extensions in Bremer County be deleted and the new description be included in the Primary Road System.

Beginning again at the north corporation line of Janesville connecting with unnamed street; thence northwesterly through Section 26 to a point approximately 274 meters (900 feet) east of the NW Corner of Section 26; thence in a northwesterly direction to a point approximately 305 meters (1,000 feet) north of the SW Corner of Section 23; thence north following substantially

the section line of Sections 23 and 14 to just north of the SW Corner Section 14; thence northwesterly, westerly and northwesterly through Sections 15, 16 and 17 to a point just north of the W ¼ Corner of Section 17; thence northerly on west section line of 17 and 8 to the NW Corner Section 8 (Intersection Iowa 3; thence northerly on the west section line of Sections 5-T91N-R14W and 32, 29, 20, 17, 8, 5-T92N-R14W and 32 and 29-T93N-R14W to approximately the W ¼ Corner of Section 29; thence northwesterly to the south corporation line of Plainfield, connecting with Main Street.

Plainfield:

Beginning on Main Street at the south corporation line; thence in a northwesterly direction on Main Street to the north corporation line.

Beginning again at the north corporation line of Plainfield connecting with Main Street; thence in a northwesterly direction through Section 19-T93N-R14W to near the N ¼ Corner of Section 19; thence northerly through the center part of Sections 18, 7 and 6 to the Bremer-Chickasaw County line at a point on the north line of Section 6-T93N-R14W, Bremer County (south line of Section 31-T94N-R14W, Chickasaw County).

#### **DISCUSSION/BACKGROUND:**

Due to the relocation of US 218 in Bremer County in 1993, the official description in the Primary Road System should be revised to reflect this change.

At the same time the old section of US 218 became Iowa 969.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended the old description of US 218 in Bremer County be deleted from the Primary Road System and the new description, as described in the attachment, be included in the Primary Road System.

New Description – US 218 and its extensions in Bremer County described as follows:

Beginning on the Bremer–Black Hawk County line at the S  $\frac{1}{4}$  Corner SW  $\frac{1}{4}$  Section 36–T91N–R14W; thence north and northwesterly in Section 36 to east corporation line of Janesville, connecting with unnamed street near the W  $\frac{1}{4}$  Corner NW  $\frac{1}{4}$  Section 36–T91N–R14W.

Janesville:

Beginning on the east corporation line connecting with unnamed street; thence northwesterly and west to the north corporation line.

Beginning again at the north corporation line of Janesville connecting with unnamed street near the W  $\frac{1}{4}$  Corner NE  $\frac{1}{4}$  Section 35–T91N–R14W; thence northwesterly through Section 26–T91N–R14W to a point approximately 900 feet east of the NW Corner of Section 26–T91N–R14W; thence in a northwesterly direction to a point approximately 1,000 feet north of the SW Corner of Section 23–T91N–R14W; thence north following substantially the section line of Sections 23 and 14–T91N–R14W to the south corporation line of Waverly, connecting with 4th Street Southwest.

Waverly:

Beginning on the south corporation line connecting with 4th Street Southwest; thence north on 4th Street Southwest to West Bremer Avenue; thence west on West Bremer Avenue to an unnamed Street; thence northwest on an unnamed

street to 20th Street Northwest; thence north on 20th Street Northwest to an unnamed street; thence northwest on unnamed street to 5th Avenue Northwest; thence west on 5th Avenue Northwest to 35th Street Northwest; the northwest, north, and northwest on 35th Street Northwest to the west corporation line.

Beginning again on the west corporation line of Waverly connecting with 35th Street Northwest; thence curving in a northwesterly direction through Section 32-T92N-R14W to a point approximately 600 feet west of the NE Corner of Section 32-T92N-R14W; thence west following substantially the section line of Section 32 to a point approximately 700 feet east of the SW Corner Section 29-T92N-R14W; thence curving in a northwesterly direction through Section 29-T92N-R14W to a point approximately 700 feet north of the SW Corner of Section 29-T92NR14W; thence north following substantially the section line of Sections 29, 20, 17, 8, and 5-T92N-R14W and Sections 32 and 29-T93N-R14W to the south corporation line of Plainfield, connecting with Main Street.

Plainfield:

Beginning on Main Street at the south corporation line; thence in a northwesterly direction on Main Street to the north corporation line.

Beginning again at the north corporation line of Plainfield connecting with Main Street; thence in a northwesterly direction through Section 19-T93N-R14W to near the N  $\frac{1}{4}$  Corner of Section 19-T93N-R14W; thence northerly through the center part of Sections 18, 7 and 6-T93N-R14W to the Bremer-Chickasaw County line at a point on the north line of Section 6-T93N-R14W, Bremer County (south line of Section 31-T94N-R14W, Chickasaw County).

#### **DISCUSSION/BACKGROUND:**

US 218 begins on Bremer-Black Hawk County line in the City of Janesville, and travels generally northerly via the Cities of Waverly and Plainfield to the Bremer-Chickasaw County line approximately four miles north of the City of Plainfield.

Due to an annexation to the City of Waverly, the present description of US 218 in Bremer County should be revised to reflect this change in corporate limits. US 218 in the Cities of Janesville and Plainfield and in the remainder of Bremer County remains unchanged.

**PROPOSAL/ACTION RECOMMENDATION:**

It is recommended to approve deleting the present description of US 218 in Bremer County from the primary road system and approve including the attached new description of US 218 in the primary road system.

Locate US 218 and its extensions in Bremer County as follows:

Janesville:

Beginning at an unnamed street on the Bremer–Black Hawk County line at a point approximately 1,000 feet west of the NE Corner Section 2–T90N–R14W (Black Hawk County); thence west following substantially the county line to a point approximately 1,000 feet east of the SW Corner SE  $\frac{1}{4}$  SW  $\frac{1}{4}$  Section 35–T91N–R14W (Bremer County); thence northwesterly and northerly to the north corporation line connecting with an unnamed street.

Beginning at the north corporation line of the City of Janesville connecting with an unnamed street; thence in a northerly direction through Sections 35 and 26–T91N–R14W to a point approximately 900 feet east of the NW Corner of Section 26–T91N–R14W; thence in a northwesterly direction to a point approximately 1,000 feet north of the SW Corner of Section 23–T91N–R14W; thence north following substantially the section line of Sections 23 and 14–T91N–R14W to the south corporation line of the City of Waverly, connecting with an unnamed street.
