



Beginning on the Black Hawk–Benton County line at a point approximately 1,200 feet east of the SW Corner of Section 36–T87N–R12W, Black Hawk County (NW Corner of Section 1–T86N–R12W, Benton County); thence north through said Section 36 to the south corporation line of La Porte City connecting with Commercial Street.



La Porte City:

Beginning on the south corporation line at Commercial Street; thence northerly on Commercial Street to 4th Street; thence northwesterly on 4th Street to the north corporation line.

Beginning again on the north corporation line of La Porte City connecting with 4th Street; thence in a northwesterly direction through Section 23-T87N-R12W to a point near the NW Corner of Section 23-T87N-R12W; thence in a northwesterly direction through Sections 14, 15, 10, 3, and 4-T87N-R12W, and Sections 33, 28, and 29-T88N-R12W to a point approximately 600 feet west of the E $\frac{1}{4}$ Corner of Section 29-T88N-R12W; thence in a northwesterly direction through Sections 29, 20, 19, and 18-T88N-R12W to the south corporation line of Waterloo connecting with Washington Street.




Waterloo:

Beginning on Washington Street at the south corporation line; thence northwesterly on Washington Street to Interstate 380; thence northwesterly and northerly on Interstate 380 to Mitchell Street connecting with Washington Street; thence northwesterly on Washington Street to approximately 740 feet west of West 11th Street, connecting with an unnamed street; thence northwesterly and westerly on said unnamed street to intersection of US 63

ramp, connecting with Washington Street (approximately 475 feet south of the NE Corner Section 27-T89N-R13W); thence northwesterly on Washington Street to Greenhill Road; thence northerly on Washington Street to Broadway Street; thence west on Broadway Street to the west corporation line (approximately 1520 feet south of the N ¼ Corner Section 8-T89N-R13W).

Beginning again on the west corporation line of Waterloo, connecting with Broadway Street (approximately 1520 feet south of the N ¼ Corner Section 8-T89N-R13W); thence westerly through Sections 8 and 7-T89N-R13W to the interchange of Iowa 57/Iowa 58; thence northerly to the south corporation line of Cedar Falls, connecting with an unnamed street (approximately 1330 feet south of the N ¼ Corner Section 7-T89N-R13W).



Cedar Falls:

Beginning again on the south corporation line, (approximately 1330 feet south of the N $\frac{1}{4}$ Corner Sec.7-T89N-R13W then northerly to the north corporation line (approximately 1300 feet north and 1920 feet east of the SW Corner Section 30-T90N-R13W).

Beginning again on the north corporation line of Cedar Falls, (approximately 1300 feet north and 1920 feet east of the SW Corner Section 30-T90N-R13W); thence in a northerly and northwesterly direction through Sections 30 and 19-T90N-R13W and Sections 24, 13, 12 and 1-T90N-R14W to the south corporation line of Janesville, connecting with an unnamed street (approximately 730 feet east of the E $\frac{1}{4}$ Corner Section 1-T90N-R14W).

Janesville:

Beginning at the south corporation line, connecting with an unnamed street (approximately 730 feet east of the E $\frac{1}{4}$ Corner Section 1-T90N-R14W); thence northerly to the Black Hawk-Bremer County line at the N $\frac{1}{4}$ Corner NW $\frac{1}{4}$ Section 1-T90N-R14W.

Beginning on the Black Hawk–Benton County line at a point approximately 1,200 feet east of the SW Corner of Section 36–T87N–R12W, Black Hawk County (NW Corner of Section 1–T86N–R12W, Benton County); thence north through said Section 36 to the south corporation line of La Porte City connecting with Commercial Street.

La Porte City:

Beginning on the south corporation line at Commercial Street; thence northerly on Commercial Street to 4th Street; thence northwesterly on 4th Street to the north corporation line.

Beginning again on the north corporation line of La Porte City connecting with 4th Street; thence in a northwesterly direction through Section 23–T87N–R12W to a point near the NW Corner of Section 23–T87N–R12W; thence in a northwesterly direction through Sections 14, 15, 10, 3, and 4–T87N–R12W, and Sections 33, 28, and 29–T88N–R12W to a point approximately 600 feet west of the E ¼ Corner of Section 29–T88N–R12W; thence in a northwesterly direction through Sections 29, 20, 19, and 18–T88N–R12W to the south corporation line of Waterloo connecting with Washington Street.

Waterloo:

Beginning on Washington Street at the south corporation line; thence northwesterly on Washington Street to Interstate 380; thence northwesterly and northerly on Interstate 380 to Mitchell Street connecting with Washington Street; thence northwesterly on Washington Street to approximately 740 feet west of West 11th Street, connecting with an unnamed street; thence northwesterly and westerly on said unnamed street to intersection of US 63 ramp, connecting with Washington Street (approximately 475 feet south of the NE Corner Section 27–T89N–R13W); thence northwesterly on Washington Street to Greenhill Road; thence northerly on Washington Street to Broadway Street; thence west on Broadway Street to the west corporation line (approximately 1520 feet south of the N ¼ Corner Section 8–T89N–R13W).

Beginning again on the west corporation line of Waterloo, connecting with Broadway Street (approximately 1520 feet south of the N ¼ Corner Section 8-T89N-R13W); thence westerly through Sections 8 and 7-T89N-R13W to the interchange of Iowa 57/Iowa 58; thence northerly to the south corporation line of Cedar Falls, connecting with an unnamed street (approximately 1330 feet south of the N ¼ Corner Section 7-T89N-R13W).

Cedar Falls:

Beginning again on the south corporation line, connecting with an unnamed street (approximately 1330 feet south of the N ¼ Corner Sec.7-T89N-R13W then northerly on said unnamed street to the north corporation line (approximately 1300 feet north and 1920 feet east of the SW Corner Section 30-T90N-R13W).

Beginning again on the north corporation line of Cedar Falls, connecting with an unnamed street (approximately 1300 feet north and 1920 feet east of the SW Corner Section 30-T90N-R13W); thence in a northerly and northwesterly direction through Sections 30 and 19-T90N-R13W and Sections 24, 13, 12 and 1-T90N-R14W to the south corporation line of Janesville, connecting with an unnamed street (approximately 730 feet east of the E ¼ Corner Section 1-T90N-R14W).

Janesville:

Beginning at the south corporation line, connecting with an unnamed street (approximately 730 feet east of the E ¼ Corner Section 1-T90N-R14W); thence northerly on said unnamed street to the Black Hawk-Bremer County line at the N ¼ Corner NW ¼ Section 1-T90N-R14W.

Due to the relocation of US 218 in Waterloo, the official description in the Primary Road System should be revised to reflect this change.

Transfer of jurisdiction agreement number 92-TJ-001 between the Iowa Department of Transportation and the City of Waterloo transferred a section of old US 218 to the City of Waterloo on December 31, 1992 that should be removed from the Primary Road System.

Due to the review of our Primary Road System records, US 218 in Black Hawk County should be deleted and the new description added should be officially included into the Primary Road System.

US 218 begins at the Black Hawk-Benton County line approximately ¼ mile south of La Porte City traveling in a northwesterly direction to the Black Hawk-Bremer County line into Janesville via the Cities of La Porte City, Waterloo and Cedar Falls, Iowa.

PROPOSAL/ACTION RECOMMENDATION:

Locate US 218 and its extension in Black Hawk County as follows:

Beginning on the Black Hawk–Benton County line at a point approximately 1,200 feet east of the SW Corner of Section 36–T87N–R12W, Black Hawk County (NW Corner of Section 1–T86N–R12W, Benton County); thence north through said Section 36 to the south corporation line of the City of La Porte City connecting with an unnamed street.

La Porte City:
