COMES NOW the Iowa Board of Pharmacy (“Board”) and files this Notice of Hearing and Statement of Charges against Food Land Pharmacy (“Respondent”), pursuant to Iowa Code §§ 17A.12(2) and 272C.3(1)(e), and 657 Iowa Administrative Code (“IAC”) 35.6 and 35.7.

A. TIME, PLACE AND NATURE OF HEARING

1. **Hearing.** A contested case hearing shall be held on May 21, 2025, before the Board. The hearing shall begin at 10:00 a.m. and shall be located in the conference room at the office of the Iowa Board of Pharmacy, 6200 Park Avenue, Ste. 100, Des Moines, Iowa 50319.
2. **Prehearing Conference.** A prehearing conference to schedule pre-hearing deadlines shall be held by telephone on April 18, 2025 at 8:00 a.m. before Administrative Law Judge Morgan from the Iowa Department of Inspections, Appeals and Licensing (ALJ) at the following conference line, 855-638-5575. Board rules on prehearing conferences may be found at 657 IAC 35.22.
3. **Answer.** Within twenty (20) days of the date you are served this Notice of Hearing and Statement of Charges you may file an Answer. In that Answer, you should also state whether you will request a continuance of the date and time of the hearing.
4. **Filing of Pleadings.** Pleadings shall be filed with the Board at the following address: Iowa Board of Pharmacy, 6200 Park Avenue, Ste. 100, Des Moines, Iowa 50319, by email to amanda.woltz@iowa.gov, or electronically using the Administrative Electronic Document

Management System (adminhearings.iowa.gov/efile/).

5. **Presiding Officer.** The Board shall serve as presiding officer at the contested case hearing, but the Board hereby delegates to an Administrative Law Judge from the Department of Inspections, Appeals and Licensing, the authority to make initial rulings on prehearing matters, and requests the administrative law judge be present to assist and advise the Board at hearing.

6. **Hearing Procedures.** The procedural rules governing the conduct of the hearing are found at 657 IAC 35.25. At the hearing, you may appear personally or be represented by legal counsel at your own expense. You will be allowed the opportunity to respond to the charges against you, to produce evidence on your behalf on issues of material fact, cross-examine witnesses present at the hearing, and examine and respond to any documents introduced at hearing. If you need to request an alternative time or date for hearing, you must comply with the requirements of 657 IAC 35.23. The hearing may be open to the public or closed to the public at the discretion of the Respondent.

7. **Prosecution.** The Office of the Attorney General is responsible for representing the public interest (the State) in this proceeding. Pleadings shall be filed with the Board and copies should be provided to counsel for the State at the following address: Lindsey L. Browning and David Merchan, Assistant Attorneys General, Iowa Department of Justice, Office of the Iowa Attorney General, 1305 E. Walnut Street, 2nd Floor, Des Moines, Iowa 50309.

8. **Communications.** You may not contact Board members in any manner, including by phone, letter, facsimile, in person or e-mail, about this Notice of Hearing and Statement of Charges. Board members may only receive information about the case when all parties have notice and an opportunity to participate, such as at the hearing or in pleadings you file with the Board and serve upon all parties in the case. B. LEGAL AUTHORITY AND JURISDICTION

9. **Iowa License.** Respondent maintains Iowa pharmacy license 1568. Respondent's license is active and subject to probation and will next expire on December 31, 2025. Respondent also maintains Iowa CSA-Business registration number 1108059. Respondent's Iowa CSA-Business registration is active and subject to probation and will next expire on May 31, 2025.

10. **Jurisdiction.** The Board has jurisdiction in this matter pursuant to Iowa Code § 155A.

11. **Legal Authority.** If any of the allegations against you are founded, the Board has authority to take disciplinary action against you under Iowa Code § 155A and 657 IAC 36.1.

12. **Default.** The Board may enter a default decision or proceed with the hearing and render a decision in your absence, in accordance with Iowa Code § 17A.12(3) and 657 IAC 35.27.

C. STATEMENT OF CHARGES

COUNT I

13. Respondent is charged under 657 IAC 6.16 for failing to follow Board rules regarding accurate record-keeping and maintenance.

COUNT II

14. Respondent is charged under 657 IAC 8.4(4) for failing to follow Board rules regarding maintaining logs of all temporary or intermittent pharmacy staff.

COUNT III

15. Respondent is charged under 657 IAC 10.9(5)(b) for failing to follow proper procedure to change the responsible individual authorized by the controlled substances registration.

COUNT IV

16. Respondent is charged under 657 IAC 8.35(6) for failing to follow proper procedure for a change of the pharmacist in charge.

COUNT V

17. Respondent is charged under 657 IAC 10(14) for failing to follow Board rule regarding accountability of controlled substances.

COUNT VI

18. Respondent is charged under 657 IAC 10.20 for failing to follow Board rule regarding Schedule III through V accountability.

COUNT VII

19. Respondent is charged under 657 IAC 21.3 for failing to follow Board rule regarding system security and safeguards.

COUNT VIII

20. Respondent is charged under 657 IAC 36.6(28) for failing to create and maintain complete and accurate records as required by state or federal law or regulation or rule of the board.

COUNT IX

21. Respondent is charged under 657 IAC 8.21(1) for failing to comply with the required drug utilization review process for a patient.

COUNT X

22. Respondent is charged under Iowa Code 124 for violating Iowa law with regard to controlled substances.

D. STATEMENT OF THE MATTERS ASSERTED

23. **Practice Setting.** Respondent is an Iowa pharmacy located in Woodbine, Iowa.

24. **Allegations.** A short and plain Statement of the Matters Asserted (Statement) was reviewed and approved by the Board at the time this Notice of Hearing and Statement of Charges was filed. The Statement shall be furnished to Respondent as an attachment to this Notice of Hearing and Statement of Charges. However, the Statement is not a public record pursuant to Iowa Code § 272C.6(4)(a).

E. SETTLEMENT

25. This matter may be resolved by settlement agreement. The procedural rules governing the Board's settlement process are found at 657 IAC 35.24. If you are interested in pursuing settlement of this matter, please contact the Assistant Attorney General identified above.

F. PROBABLE CAUSE FINDING

26. On March 4, 2025, the Iowa Board of Pharmacy found probable cause to file this Notice of Hearing and Statement of Charges.
