
**VOLUNTARY CANCELLATION AND
SURRENDER OF CSA REGISTRATION**

COMES NOW the Iowa Board of Pharmacy (Board) and Carl Markley (Respondent) and hereby enters into this agreement for cancellation and surrender of Respondent's CSA registration, and hereby states as follows:


1. The Respondent was issued an Iowa CSA registration by the Iowa Board of Pharmacy.
2. The Respondent was previously issued a DEA registration by the United States of America.
3. The Respondent surrendered his DEA registration on October 18, 2023 and no longer holds a DEA registration.
4. The Respondent was previously issued license no. A127170 to practice from the Iowa Board of Nursing.
5. The Respondent surrendered nursing license no. A127170 on May 26, 2023 pursuant to a Combined Statement of Charges, Settlement Agreement and Final Order.
6. Pursuant to Iowa Code 124.303(f) and 124.304(e) and 657 IAC 10.10(1)(d) and (e), Respondent is subject to revocation of his CSA registration because "the registrant has had the registrant's professional license revoked or suspended, or has been otherwise disciplined in a way that restricts the registrant's authority to handle or prescribe controlled substances."
7. The Respondent, Carl Markley, hereby surrenders any and all CSA registrations effective immediately.
8. The Respondent acknowledges the surrender of his CSA registration is voluntary and not the result of force, threats, or promises.
9. The Respondent is of sound mind and has the mental capacity to understand the consequences of surrendering his CSA registration.

10. The Respondent is aware of the Board's legal authority to discipline my CSA registration, up to and including revocation of his CSA registration.
11. The Respondent understands that he has the opportunity to be heard and to contest the allegations against me in a contested case hearing before the Board, but waive the right to a hearing and all attendant rights, including the right to present evidence, cross-examine witnesses, and seek judicial review, but surrendering my CSA registration.
12. The Respondent understands that he has the right to be represented by counsel, at my own expense, in this matter.
13. The Respondent understands that the surrender of his CSA registration is considered a revocation of CSA registration pursuant to 657 IAC 36.8. The Respondent understands the surrender of CSA registration is disciplinary in nature and is considered adverse action.
14. The Respondent understands the Board is required by federal law to report this surrender to the National Association of Boards of Pharmacy's Disciplinary Clearinghouse and the National Practitioner Data Bank.
15. The Respondent acknowledges, after signing this document, Respondent does not have the ability to administer, dispense, or prescribe controlled substances in Iowa in any capacity unless and until his CSA registration is reinstated.
16. The Respondent understands that any future request for reinstatement will be governed by the Board's rules regarding reinstatement described in 657 IAC 35.36.
17. The Respondent understands this document is a public record and is available for inspection and copying in accordance with the requirements of Iowa Code chapter 22.
